COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 6) NOTIFICATION 2012

ARRANGEMENT OF PARAGRAPHS

Paragraph

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 6) Notification 2012.

Exemption

- 2.—(1) The Minister hereby exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of the "One Million Visitors Celebration Lucky Draw" promotion to be held on 5th February 2012 from 6.30 p.m. to 8.30 p.m. and the draw to be held on 5th February 2012 at 8.30 p.m. at the Event Plaza of Marina Bay Sands.
- (2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution, and if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. The draw shall be conducted by persons in the employment of Marina Bay Sands Pte. Ltd. only.
- 3. The draw shall be conducted in public.
- 4. Any draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Marina Bay Sands Pte. Ltd.
- 5. Where the draw is conducted through the telecommunication system, participants shall not be required to pay more than 20 cents per call.
- 6. The draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 7. The draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 8. Marina Bay Sands Pte. Ltd. shall, before the start of any draw, undertake to ensure that
 - (a) all winners are notified by ordinary post or other means, including electronic means;
 - (b) the results of the draw are published in a domain where the public may have access (including the website of Marina Bay Sands Pte. Ltd.) in addition to being displayed on the casino plasma television sets after the draw is completed; and
 - (c) an audited statement of accounts is, together with the results of the draw, sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 6th May 2012.
