COMMON GAMING HOUSES (EXEMPTION) (NO. 43) NOTIFICATION 2017

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification is the Common Gaming Houses (Exemption) (No. 43) Notification 2017.

Definition

- 2. In this Notification, "organisers" means
 - (a) "The Serangoon" Community Club Management Committee;
 - (b) the Hwi Yoh Court Residents' Committee;
 - (c) the Hwi Yoh Ville Residents' Committee;
 - (d) the Hwi Yoh Garden Residents' Committee;
 - (e) the Hwi Yoh Green Residents' Committee;
 - (f) the Boundary Ville Residents' Committee;

- (g) the Serangoon Green Residents' Committee;
- (h) the Rosyth Neighbourhood Committee;
- (i) the Hillside Neighbourhood Committee;
- (j) the Hwan Gardens Neighbourhood Committee;
- (k) the Serangoon Garden Neighbourhood Committee; and
- (1) the Chartwell Neighbourhood Committee.

Exemption

- **3.**—(1) The Minister exempts the organisers from the provisions of the Act in respect of
 - (a) the "Serangoon Mahjong Challenge 2017" promotion to be held from 25 September 2017 to 5 November 2017 (both dates inclusive); and
 - (b) the mahjong games to be held at the multi-purpose hall of "The Serangoon" Community Club from 11 a.m. to 4 p.m. on 5 November 2017.
- (2) The exemption is subject to compliance by the organisers with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The only game played must be mahjong.
- 2. All players must be at least 21 years of age and residing in such area within the Aljunied Group Representation Constituency as is designated by the organisers to be the Serangoon district.
- 3. All spectators and staff must be at least 21 years of age.
- 4. Prize sponsors must not be involved in any business related to gambling.
- 5. Advertising for the mahjong competition must be confined to posters and banners displayed within the Serangoon district.
- 6. The organisers may charge an entrance fee of \$8 per player to cover the cost of hosting the mahiging competition, less the value of the prizes.

THE SCHEDULE — continued

- 7. Token prizes can be allowed in recognition of the skills shown by the winners.
- 8. The organisers must ensure that the rules of the game are explained clearly to all players before the start of the event.
- 9. The organisers must deploy umpires on site to referee the event and resolve any disputes.
- 10. The mahjong activities must be held indoors at the multi-purpose hall of "The Serangoon" Community Club.
- 11. The organisers must ensure that all doors to the multi-purpose hall of "The Serangoon" Community Club are closed during the event so as to minimise noise from the event.
- 12. The organisers must open up the premises for spot-checks by the police during the event.
- 13. The organisers must take all reasonable steps to ensure that there are no private deals or side-betting throughout the event.
