# COMMON GAMING HOUSES (EXEMPTION) (NO. 39) NOTIFICATION 2018

#### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

#### Citation

**1.** This Notification is the Common Gaming Houses (Exemption) (No. 39) Notification 2018.

#### **Definition**

- 2. In this Notification, "organisers" means
  - (a) the Kebun Baru Senior Citizens' Executive Committee;
  - (b) the Kebun Baru Active Ageing Committee; and
  - (c) the Kebun Baru Spring Residents' Committee.

## **Exemption**

- **3.**—(1) The Minister exempts the organisers from the provisions of the Act in respect of
  - (a) the "Kebun Baru Mahjong Challenge 2018" promotion to be held from 20 September 2018 to 7 October 2018 (both dates inclusive); and
  - (b) the mahjong games to be held at the multi-purpose hall of Kebun Baru Community Club from 9 a.m. to 4 p.m. on 7 October 2018.
- (2) The exemption is subject to compliance by the organisers with the conditions specified in the Schedule.

#### THE SCHEDULE

Paragraph 3

#### **CONDITIONS**

- 1. The only game played must be mahjong.
- 2. All players must be at least 50 years of age and residing in the Nee Soon Group Representation Constituency.
- 3. All spectators and staff must be at least 21 years of age.
- 4. Prize sponsors must not be involved in any business related to gambling.
- Advertising for the mahjong competition must be confined to posters and banners displayed in such area within the Nee Soon Group Representation Constituency as is designated by the organisers to be the Kebun Baru district.
- 6. The organisers may charge players an entrance fee of \$10 for PAssion Card members and \$15 for non-PAssion Card members to cover the cost of hosting the mahjong competition, less the value of the prizes.
- 7. Token prizes can be allowed in recognition of the skills shown by the winners.
- 8. The organisers must ensure that the rules of the game are explained clearly to all players before the start of the event.
- 9. The organisers must deploy umpires on site to referee the event and resolve any disputes.
- 10. The mahjong activities must be held indoors at the multi-purpose hall of Kebun Baru Community Club.

#### THE SCHEDULE — continued

- 11. The organisers must ensure that all doors to the multi-purpose hall of Kebun Baru Community Club are closed during the event so as to minimise noise from the event.
- 12. The organisers must open up the premises for spot-checks by the police during the event.
- 13. The organisers must take all reasonable steps to ensure that there are no private deals or side-betting throughout the event.
