COMMON GAMING HOUSES (EXEMPTION) (NO. 41) NOTIFICATION 2018

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification is the Common Gaming Houses (Exemption) (No. 41) Notification 2018.

Exemption

- **2.**—(1) The Minister exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of
 - (a) the "Viva Million Dollars Draw" promotion to be held from 24 September 2018 to 1 January 2019 (both dates inclusive);
 - (b) the "Weekly Draw" to be held as part of that promotion at the Royale BarTM (Level B1) at Resorts World Sentosa Singapore at 9 p.m. on the following dates:
 - (i) 30 October 2018;

- (ii) 6 November 2018, 13 November 2018, 20 November 2018 and 27 November 2018;
- (iii) 4 December 2018, 11 December 2018, 18 December 2018, 25 December 2018 and 31 December 2018; and
- (c) the "Grand Draw" to be held as part of that promotion at the Royale BarTM (Level B1) at Resorts World Sentosa Singapore at 1 a.m. on 1 January 2019.
- (2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, where the winners are determined solely or partly by a draw, the time, date and place of the draw, must be disclosed in printed publicity material, copies of which must be freely available to all participants.
- 2. Only persons in the employment of Resorts World at Sentosa Pte. Ltd. may conduct a draw.
- 3. Each draw must
 - (a) be conducted in public; or
 - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
- 4. A draw must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act to be a lottery or a game of chance or of mixed chance and skill.
- 5. A draw must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.
- 6. The results of each draw must be publicised
 - (a) through announcements using the audiovisual system; and
 - (b) through display on the plasma television set at the draw area of the casino at Resorts World Sentosa Singapore.

THE SCHEDULE — continued

7. Resorts World at Sentosa Pte. Ltd. must, before the start of the draws, undertake to ensure that an audited statement of accounts and the results of the draws are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 2 April 2019.
