# COMMON GAMING HOUSES (SINGAPORE CRICKET CLUB HERITAGE BALL RAFFLE DRAW — EXEMPTION) NOTIFICATION 2019

#### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

## Citation

**1.** This Notification is the Common Gaming Houses (Singapore Cricket Club Heritage Ball Raffle Draw — Exemption) Notification 2019.

#### Exemption

**2.**—(1) The Minister exempts Singapore Cricket Club (called in this Notification the organiser) from the provisions of the Act in respect of —

(*a*) the "Singapore Cricket Club Heritage Ball Raffle Draw" promotion to be held from 17 September 2019 to 25 October 2019 (both dates inclusive); and (*b*) the draw to be held as part of that promotion at 10 p.m. on 25 October 2019 at InterContinental Singapore, 80 Middle Road, Singapore 188966.

(2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

### THE SCHEDULE

Paragraph 2

#### CONDITIONS

- 1. The price of the draw ticket, the name of the organiser, and the details of the prizes to be distributed, must be clearly stated on each draw ticket.
- 2. Each draw ticket must only be issued by way of sale and upon receipt of its price in full.
- 3. The name, membership number (if available), NRIC number (partial), contact number and email address of the purchaser of each draw ticket must be recorded on the counterfoil of that ticket.
- 4. The draw must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act to be a lottery or a game of chance or of mixed chance and skill.
- 5. The draw must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.
- 6. The organiser must, before the start of the draw, undertake to ensure that
  - (a) every winner is notified by telephone or email; and
  - (b) the results of the draw are published on the website at https://www.scc.org.sg.

#### THE SCHEDULE — continued

7. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 26 January 2020.
