COMMON GAMING HOUSES (EXEMPTION) (NO. 12) NOTIFICATION 2014

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 12) Notification 2014.

Exemption

- 2.—(1) The Minister hereby exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of the "RWS 100 Seconds Slots Challenge" promotion to be held from 10th February 2014 to 9th March 2014 (both dates inclusive) and the draw to be held on 9th March 2014 at 10.30 p.m. at the Casino Royale Bar at Resorts World at Sentosa.
- (2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. Every draw shall be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd. only.
- 3. Every draw shall be conducted in public.
- 4. Every draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
- 5. Every draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 6. Every draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 7. Resorts World at Sentosa Pte. Ltd. shall, before the start of the draw, undertake to ensure that
 - (a) the results of the draw will be announced via the AV system at the draw area, in addition to being displayed on the prize board located at the Casino Royale Bar at Resorts World at Sentosa, after the draw is completed; and
 - (b) an audited statement of accounts shall, together with the results of the draw, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 10th June 2014.
