### COMMON GAMING HOUSES ACT (CHAPTER 49)

#### COMMON GAMING HOUSES (EXEMPTION) (NO. 7) NOTIFICATION 2018

##### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

#### **Citation**

1. This Notification is the Common Gaming Houses (Exemption) (No. 7) Notification 2018.

#### **Exemption**

2.—(1) The Minister exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of —

- (a) the “Matching Mania” promotion to be held from 19 February 2018 to 13 April 2018 (both dates inclusive);
- (b) the “Instant Win Kiosk Game” to be held as part of that promotion within the premises of the casino at Resorts World Sentosa Singapore during the following periods:
  - (i) from 12.01 a.m. on 17 March 2018 to 8.30 p.m. on 23 March 2018;

- (ii) from 12.01 a.m. on 24 March 2018 to 8.30 p.m. on 30 March 2018;
  - (iii) from 12.01 a.m. on 31 March 2018 to 8.30 p.m. on 6 April 2018;
  - (iv) from 12.01 a.m. on 7 April 2018 to 8.30 p.m. on 13 April 2018; and
- (c) the draws to be held as part of that promotion at the Casino Royale Bar<sup>TM</sup> (Level B1) at Resorts World Sentosa Singapore at 9 p.m. every Friday from 23 March 2018 to 13 April 2018 (both dates inclusive).

(2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

## THE SCHEDULE

Paragraph 2

### CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, where the winners are determined solely or partly by a lottery, the time, date and place of the lottery, must be disclosed in printed publicity material, copies of which must be freely available to all participants.
2. Only persons in the employment of Resorts World at Sentosa Pte. Ltd. may conduct a lottery.
3. Each lottery must —
  - (a) be conducted in public; or
  - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
4. A lottery must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act to be a lottery or a game of chance or of mixed chance and skill.
5. A lottery must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.

THE SCHEDULE — *continued*

6. The results of each lottery must be publicised at the draw area of the casino at Resorts World Sentosa Singapore —
  - (a) through announcements using the audiovisual system; and
  - (b) through display on plasma television sets.
7. Resorts World at Sentosa Pte. Ltd. must, before the start of the lotteries, undertake to ensure that an audited statement of accounts and the results of the lotteries are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 14 July 2018.
