### CONSTITUTION OF THE REPUBLIC OF SINGAPORE (RESPONSIBILITY OF THE MINISTER FOR SOCIAL AND FAMILY DEVELOPMENT) NOTIFICATION 2015

#### **Responsibility of Minister for Social and Family Development**

It is notified for general information that, pursuant to Article 30(1) of the Constitution of the Republic of Singapore, the Prime Minister has directed that, with effect from 9 April 2015, Mr Tan Chuan-Jin is charged with the responsibility for the departments and subjects set out in the Schedule, and designated as the Minister for Social and Family Development.

#### **Citation**

2. This Notification may be cited as the Constitution of the Republic of Singapore (Responsibility of the Minister for Social and Family Development) Notification 2015.

#### **Cancellation**
