#### CONSTITUTION OF THE REPUBLIC OF SINGAPORE (RESPONSIBILITY OF THE MINISTER FOR COMMUNICATIONS AND INFORMATION) NOTIFICATION 2012

### **Responsibility of Minister for Communications and Information**

It is hereby notified for general information that, pursuant to Article 30(1) of the Constitution of the Republic of Singapore, the Prime Minister has directed that Dr Yaacob Ibrahim shall, with effect from 1st November 2012, be charged with the responsibility for the departments and subjects set out in the Schedule, and that he shall be designated as the Minister for Communications and Information.

### **Citation**

2. This Notification may be cited as the Constitution of the Republic of Singapore (Responsibility of the Minister for Communications and Information) Notification 2012.

### **Cancellation**

3. The Constitution of the Republic of Singapore (Responsibility of the Minister for Information, Communications and the Arts) Notification 2011 (G.N. No. S 303/2011) is cancelled.
