NOTIFICATION 2015

Responsibility of Minister for Home Affairs

It is notified for general information that the Prime Minister has, under Article 30(1) of the Constitution of the Republic of Singapore, directed that with effect from 1 October 2015, Mr K Shanmugam is charged with the responsibility for the departments and subjects set out in the Schedule and designated as the Minister for Home Affairs.

Citation

2. This Notification may be cited as the Constitution of the Republic of Singapore (Responsibility of the Minister for Home Affairs) Notification 2015.
