In exercise of the powers conferred by section 27 of the COVID-19 (Temporary Measures) Act 2020, the Minister for Law makes the following Order:

### Citation and commencement

1. This Order is the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings of Singapore Labour Foundation) Order 2021 and comes into operation on 21 May 2021.

### **Definitions**

- **2.** In this Order, unless the context otherwise requires
  - "Board" means the Board of Directors constituted under section 7(1) of the Singapore Labour Foundation Act (Cap. 302);
  - "electronic means" means electronic communication, video conferencing, tele-conferencing or other electronic means;

- "Foundation" means the Singapore Labour Foundation established under section 3 of the Singapore Labour Foundation Act;
- "meeting" means
  - (a) a meeting of the Foundation; or
  - (b) a meeting of the Board;
- "member" means
  - (a) in the case of a meeting of the Foundation a member of the Foundation; or
  - (b) in the case of a meeting of the Board a member of the Board.

### **Application**

**3.** This Order sets out the alternative arrangements to personal attendance in respect of the meetings of the Foundation and the meetings of the Board.

# Alternative arrangements for meetings of Foundation and meetings of Board

**4.** The alternative arrangements for the convening, holding or conducting of a meeting of the Foundation or a meeting of the Board set out in the second column of the Schedule apply in respect of the provisions of the written law relating to such a meeting set out in the first column of that Schedule.

# ALTERNATIVE ARRANGEMENTS FOR MEETINGS OF FOUNDATION AND MEETINGS OF BOARD

 Provision for convening, holding or conducting of a meeting A meeting may be convened, held or conducted, whether wholly or partly, by electronic means if the following are satisfied:

- (a) all members who wish to participate at a meeting have access to the technology needed to participate in the meeting;
- (b) a quorum of members can simultaneously communicate with each other throughout the meeting.
- 2. Provision for attendance at a meeting

A member may attend a meeting by electronic means.

3. Provision for quorum at a meeting

A quorum may be formed by members personally or electronically present and satisfying the relevant quorum requirements.

A member is electronically present at a meeting if the member attends the meeting in the manner provided in item 2

4. Provision for a member of the Foundation to vote at a meeting of the Foundation

A member of the Foundation —

(a) may be required to appoint the chairman of the meeting as the member's proxy to vote at a meeting of the Foundation by depositing with the Foundation an instrument of appointment by any electronic means as the Foundation considers appropriate; and

- (b) where paragraph (a) applies, a member may not vote at the meeting otherwise than by way of appointing the chairman of the meeting as the member's proxy.
- Provision for a member of the Board to vote at a meeting of the Board
- 6. Provision for laying and production of documents at a meeting
- 7. Provision for giving of notice of a meeting of the Foundation

A member of the Board may vote at a meeting of the Board by electronic means.

A document required to be laid or produced before a meeting may be so laid or produced by being sent with the notice of the meeting.

A notice of a meeting of the Foundation may be sent by electronic means and —

- (a) must describe the means by which the meeting can be electronically accessed (including the online location, if the meeting is held at an online location);
- (b) must set out how the chairman of the meeting may be appointed by a member entitled to vote at the meeting as the member's proxy to vote at the meeting; and
- (c) may be accompanied by any other documents relevant to the meeting.

For the purposes of this item, a notice is sent by electronic means only if the notice is sent by electronic mail to all members at their last known electronic mail addresses.
