CO-OPERATIVE SOCIETIES (EXEMPTION) ORDER 2010

In exercise of the powers conferred by section 97 of the Co-operative Societies Act, the Minister for Community Development, Youth and Sports hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Co-operative Societies (Exemption) Order 2010 and shall be deemed to have come into operation on 1st July 2010.

Exemption

2. Every co-operative society named in the second column of the First Schedule is exempted from the provision of the Act specified opposite thereto in the first column.

Application of certain provisions of Act with modifications or conditions

3. The provision of the Act specified in the first column of the Second Schedule shall apply to each co-operative society and subject

to the modification or condition set out opposite thereto in the second and third columns, respectively.

Revocation

4. The Co-operative Societies (Exemption Orders) (Consolidation) Order (O 1) and the Co-operative Societies (Exemption) (Consolidation) Order (O 3) are revoked.
