In exercise of the powers conferred by section 4 of the Diplomatic and Consular Officers (Oaths and Fees) Act, the Minister for Foreign Affairs hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Diplomatic and Consular Officers (Fees) Order 2012 and shall come into operation on 14th February 2012.

Fees

2.—(1) The fees specified in the Schedule shall be leviable in respect of the matters or things done in the execution of his office by a diplomatic or consular officer.

(2) Such fees shall be in the equivalent local currency of the country to which such officer is accredited.

Remission of fees

3. The Minister may, in his discretion, remit wholly or in part, and either generally or in any particular case or class of cases, any fee specified in the Schedule.

Revocation

4. The Diplomatic and Consular Officers (Fees) Order (O 1) is revoked.
