Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) Order 2019 and comes into operation on 25 March 2019.

Declaration of precincts for Home Improvement Programme

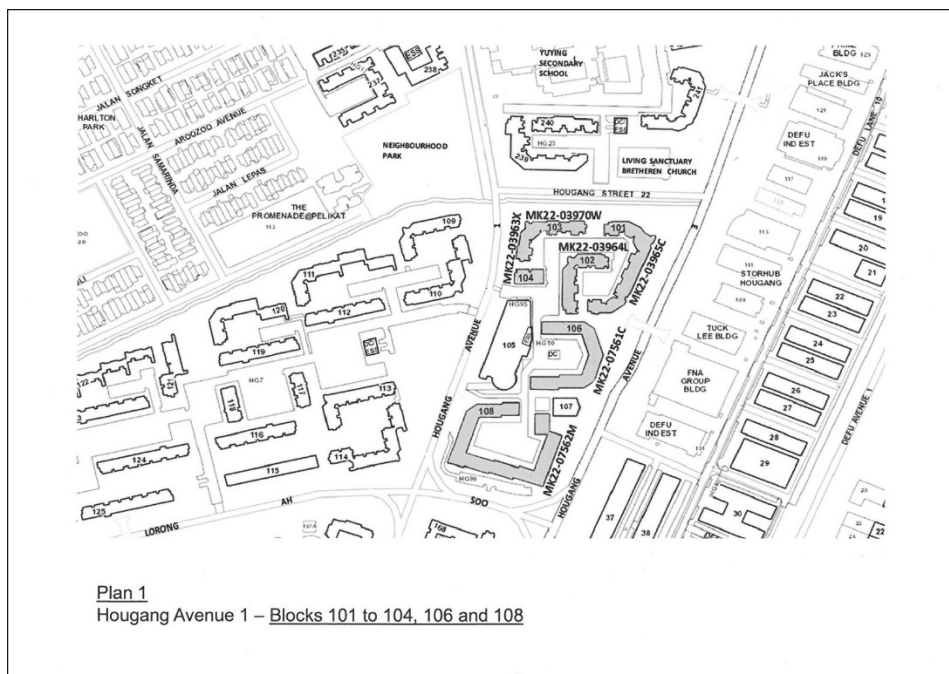
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

All that part of the housing estate of the Board bounded by Hougang Avenue 1, Lorong Ah Soo, Hougang Avenue 3 and Hougang Street 22, comprised in Lot numbers 03965C, 03964L, 03970W, 03963X, 07561C and 07562M in Mukim 22 and on which Apartment Blocks 101, 102, 103, 104, 106 and 108 are erected, and which is more particularly shaded in Plan 1.

HOUGANG AVENUE 1

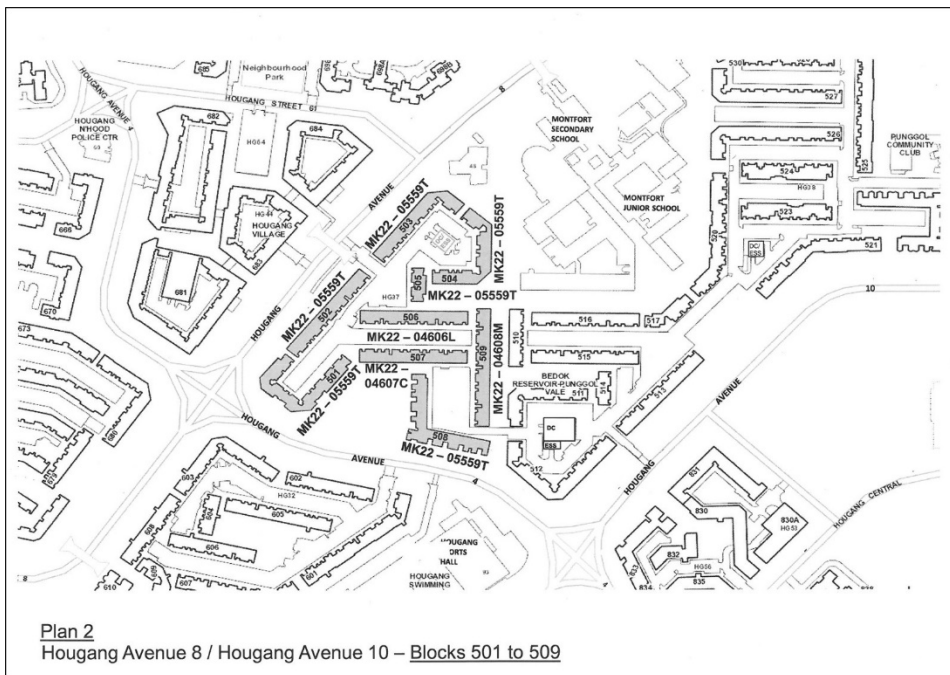

HOUGANG AVENUE 8/HOUGANG AVENUE 10

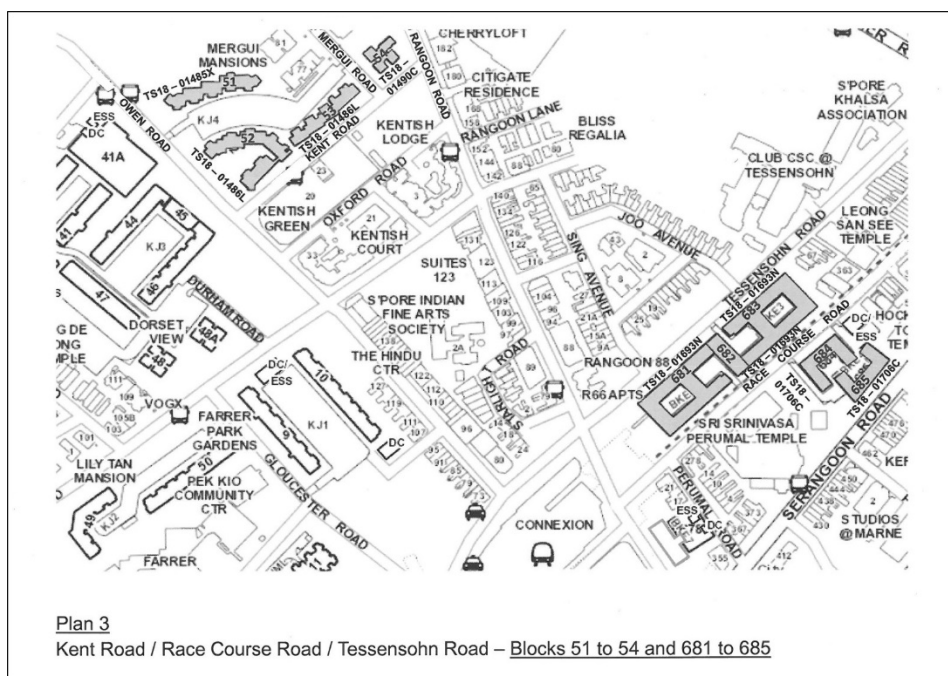

KENT ROAD/RACE COURSE ROAD/TESSENSOHN ROAD

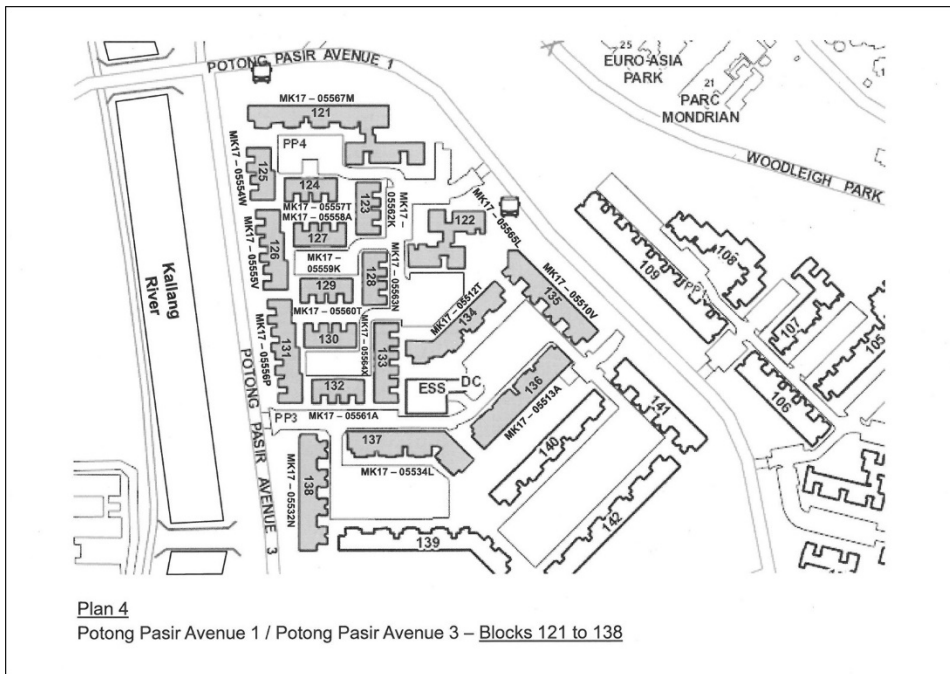

POTONG PASIR AVENUE 1/POTONG PASIR AVENUE 3

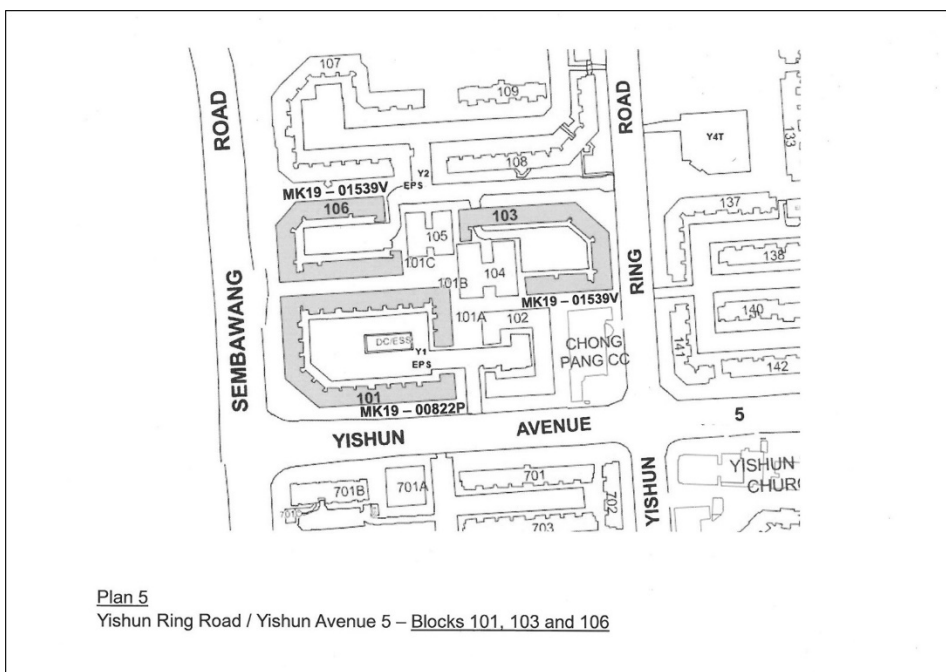

YISHUN RING ROAD/YISHUN AVENUE 5

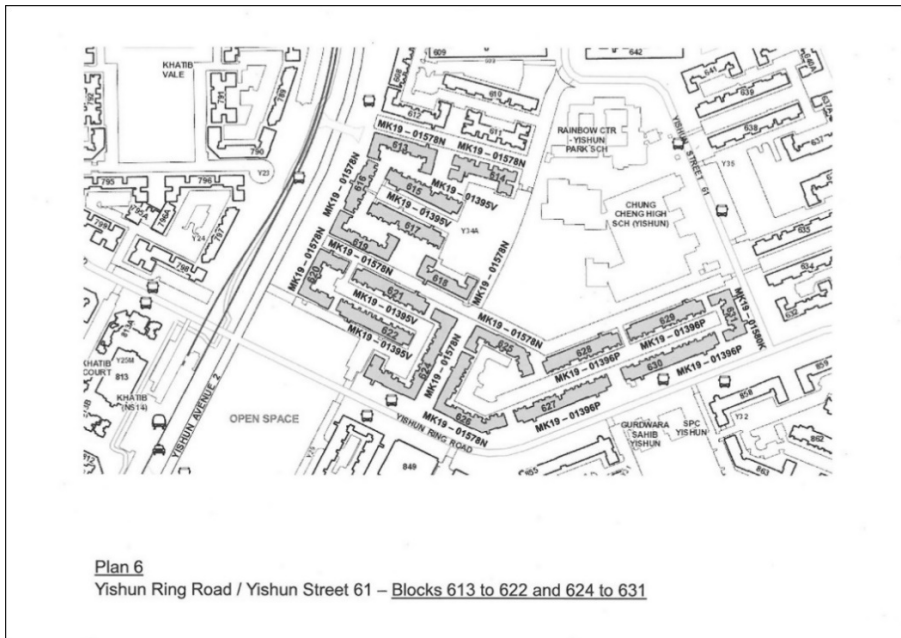
