
Declaration of precincts for lift upgrading works

HOUGANG STREET 21/AVENUE 1





Lorong Ah Soo – Blocks 129, 135, 137, 139 & 142



MARSILING RISE







Potong Pasir Avenue 1/3 – Blocks 121,122,126,131,133 to 135



POTONG PASIR AVENUE 3




Plan 6
