**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Lift Upgrading Works) (No. 6) Order 2016 and comes into operation on 14 July 2016.

**Declaration of precincts for lift upgrading works**

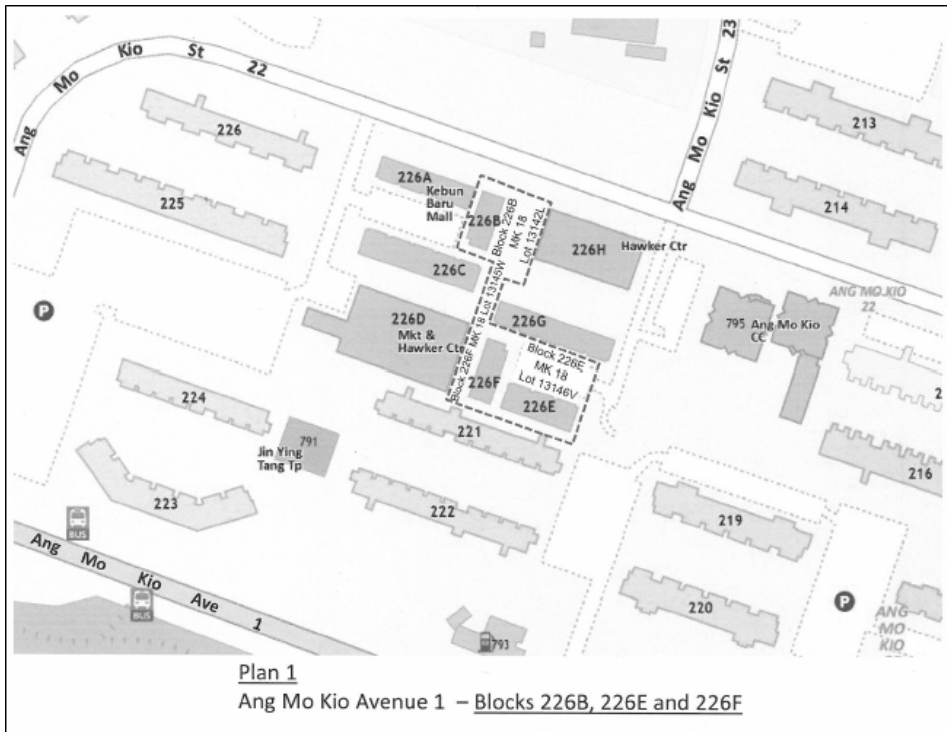
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out lift upgrading works.

1. All that part of the housing estate of the Board bounded by Ang Mo Kio Avenue 1 and Ang Mo Kio Street 22, comprised in Lot numbers 13142L, 13146V and 13145W in Mukim 18 and on which Apartment Blocks 226B, 226E and 226F are erected, and which is more particularly delineated in Plan 1.

## ANG MO KIO AVENUE 1

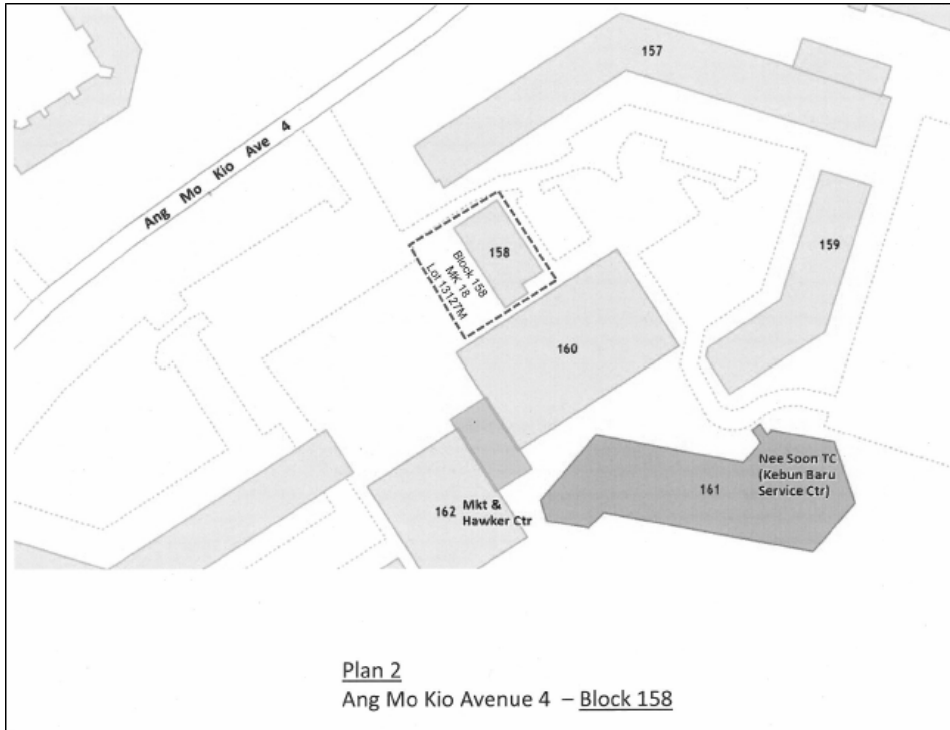

## ANG MO KIO AVENUE 4

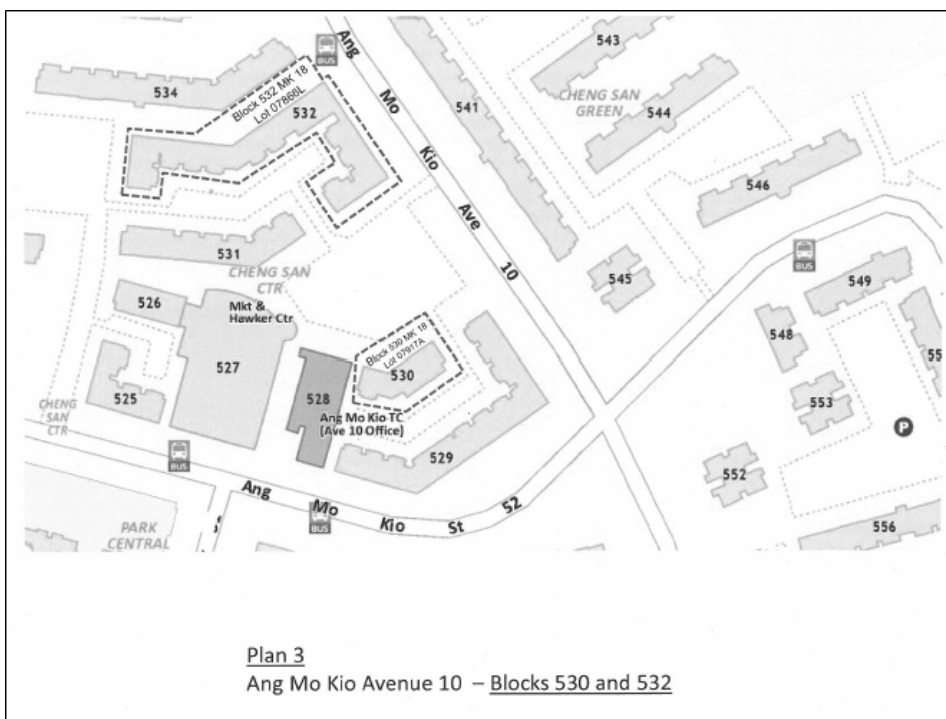

## ANG MO KIO AVENUE 10

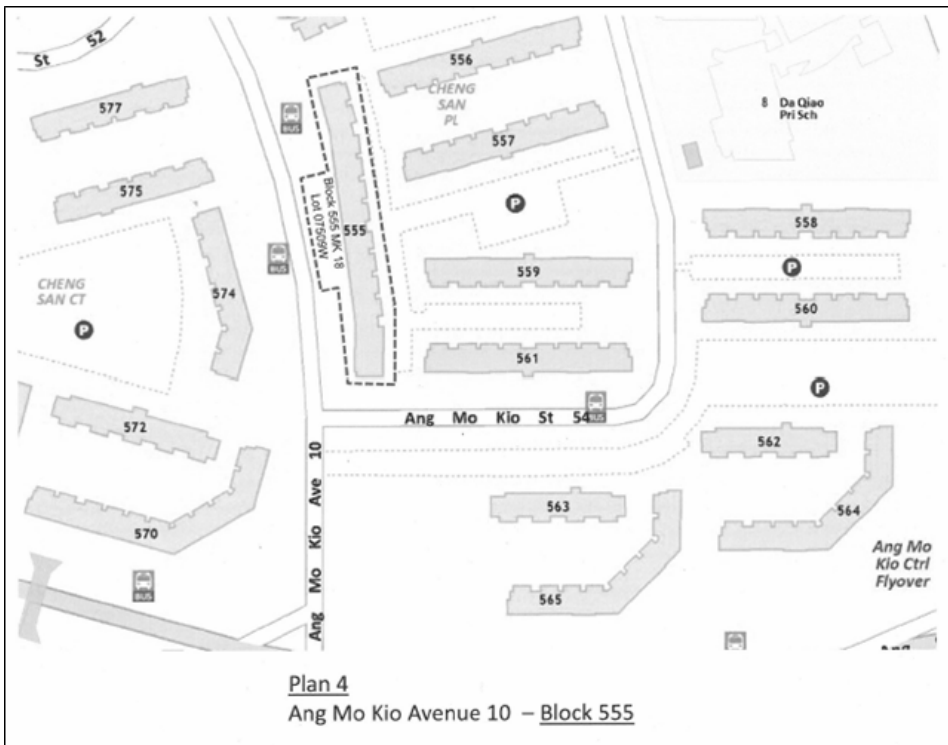

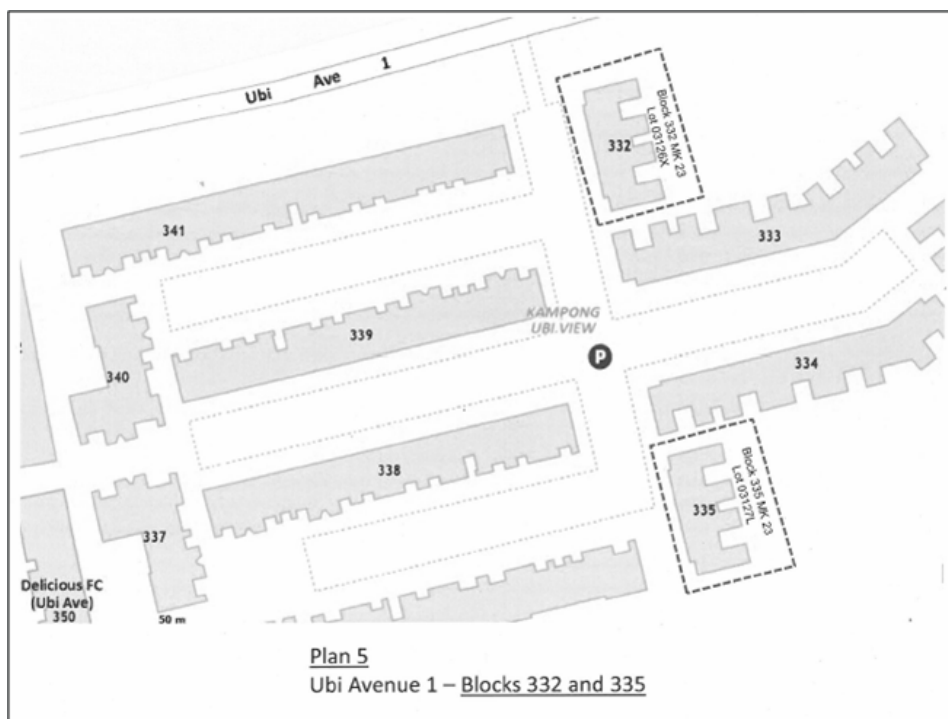
