In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 2) Order 2019 and comes into operation on 30 April 2019.

**Declaration of precincts for Home Improvement Programme**


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.






## BEDOK NORTH STREET 1/NEW UPPER CHANGI ROAD

BISHAN STREET 13



## BISHAN STREET 13









## HOUGANG AVENUE 8





## LORONG 1 TOA PAYOH


