Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 5) Order 2017 and comes into operation on 3 July 2017.

Declaration of precincts for Home Improvement Programme


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

1. All that part of the housing estate of the Board:
 - (a) bounded by Ang Mo Kio Street 42, Ang Mo Kio Avenue 3 and Ang Mo Kio Street 43, comprised in Lot numbers 07116K, 07117N, 07119L, 07118X and 07037V in Mukim 18 and on which Apartment Blocks 426, 427, 428, 429 and 430 are erected, and which is more particularly shaded in Plan 1A;




ANG MO KIO AVENUE 3/ANG MO KIO AVENUE 5

BEDOK NORTH STREET 3



CRAWFORD LANE/NORTH BRIDGE ROAD



HOUGANG AVENUE 8



POTONG PASIR AVENUE 1



TAMPINES STREET 22


