In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 3) Order 2015 and comes into operation on 10 July 2015.

Declaration of precincts for Home Improvement Programme


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Gangsa Road, Bukit Panjang Road, Pending Road and Petir Road, comprised in Lot number 01060V in Mukim 14 and on which Apartment Blocks 101, 102, 103, 104, 105, 106, 107, 108, 109, 110, 111 and 112 are erected, and in Lot number 00448X in Mukim 14 and on which Apartment Blocks 113 and 115 are erected, and which is more particularly shaded in Plan 1.

GANGSA ROAD/PENDING ROAD



2. All that part of the housing estate of the Board bounded by Yishun Street 22, Yishun Avenue 7 and Yishun Avenue 6, comprised in Lot numbers 01044X, 01077C, 01043N, 01042K, 01041A, 01302V, 01301W, 01300M and 01299L in Mukim 19 and on which Apartment Blocks 276, 277, 278, 279, 280, 283, 284, 286 and 287 are erected, and in Lot number 01637X in Mukim 19 and on which Apartment Blocks 281, 282, 285, 288 and 289 are erected, and which is more particularly shaded in Plan 2.
