**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Lift Upgrading Works) (No. 9) Order 2016 and comes into operation on 23 September 2016.

**Declaration of precincts for lift upgrading works**

2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out lift upgrading works.


**THE SCHEDULE**

## PLAN 1


## ANG MO KIO AVENUE 1




