2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

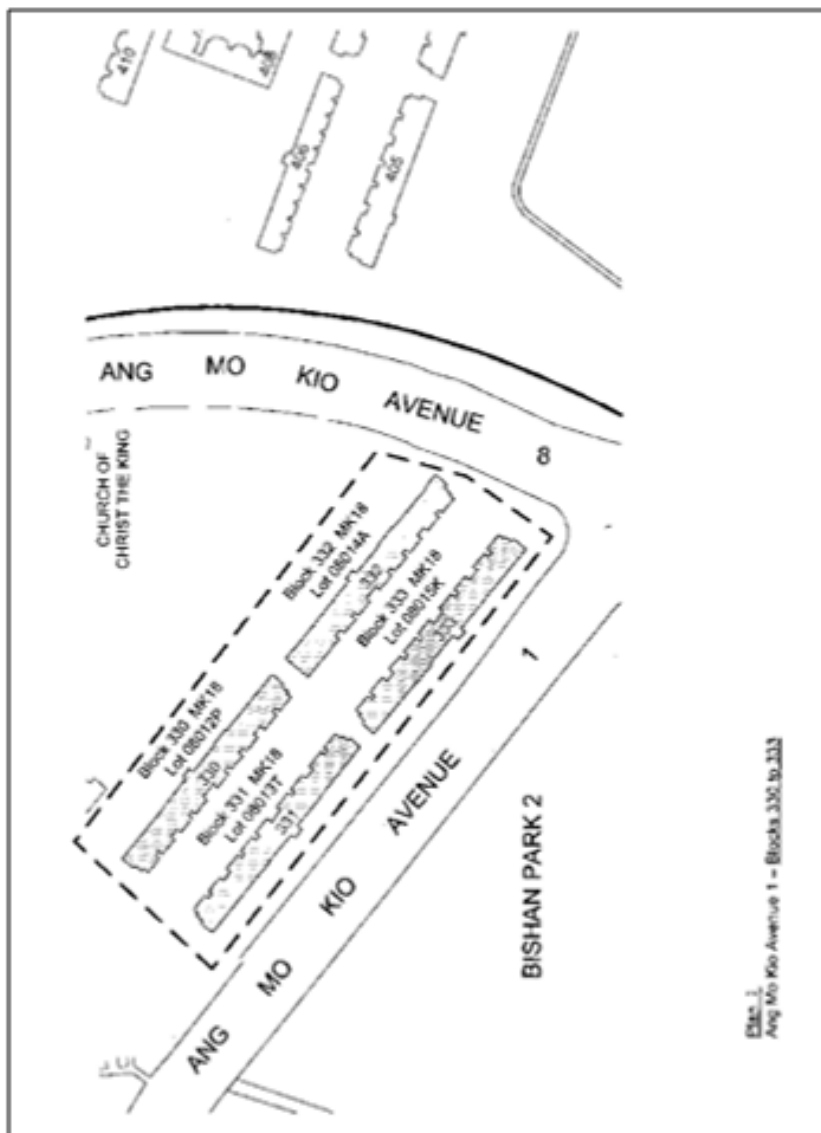

ANG MO KIO AVENUE 1



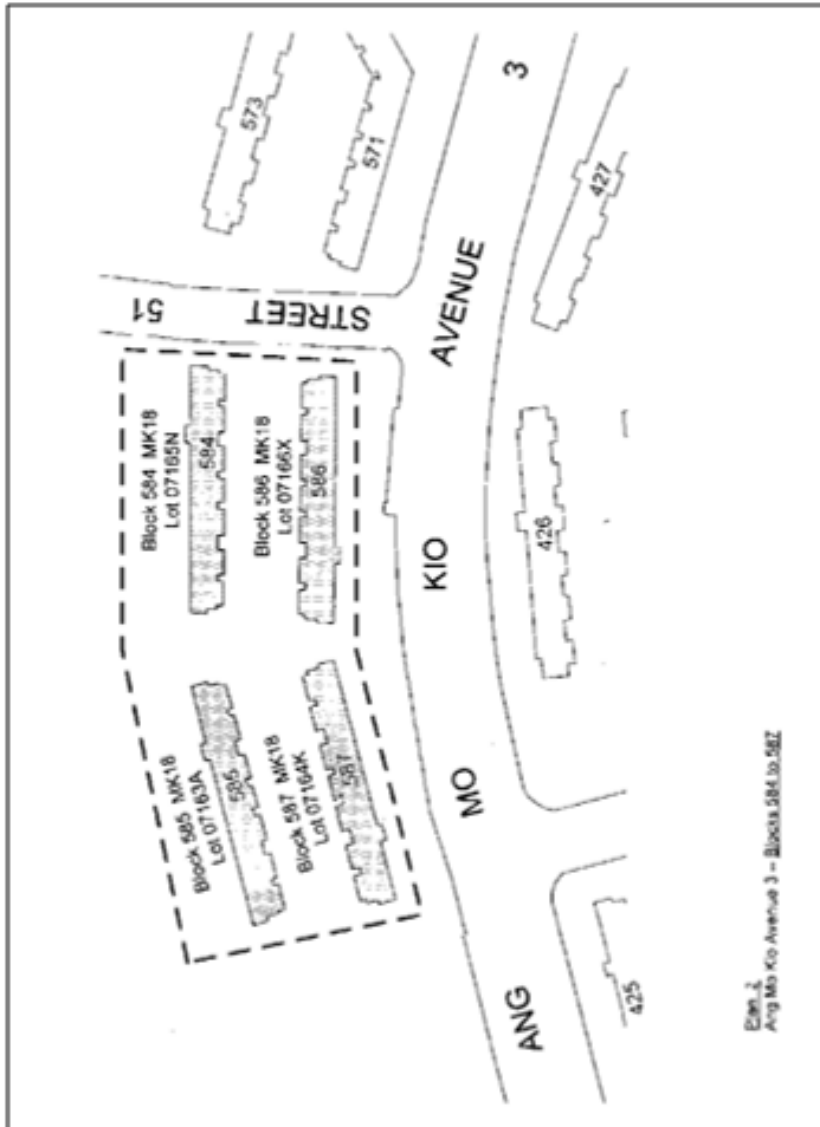

ANG MO KIO AVENUE 3



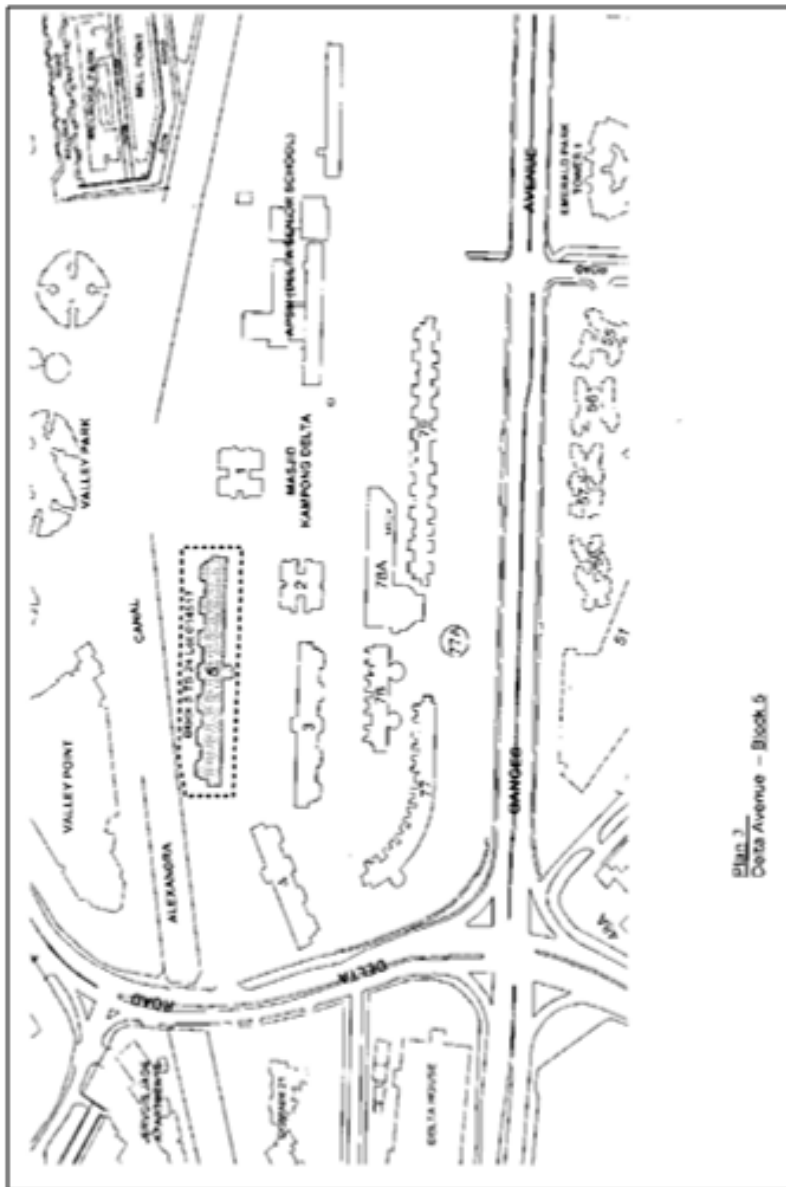

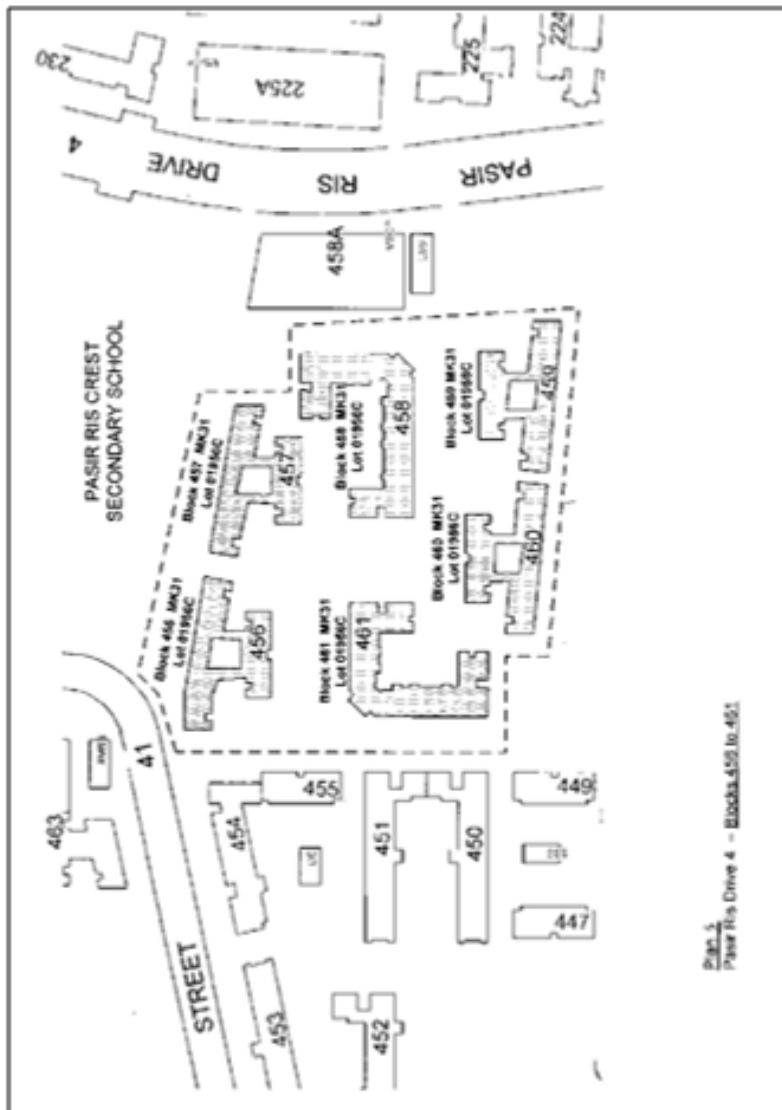

PASIR RIS DRIVE 4



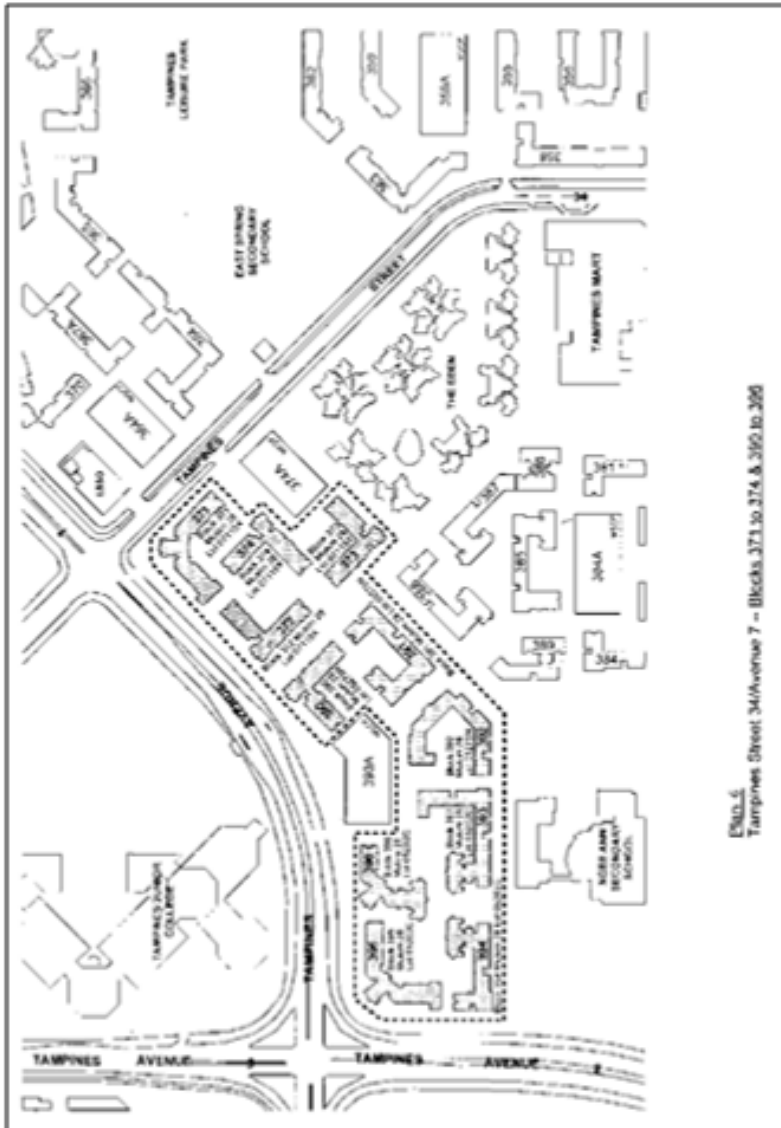

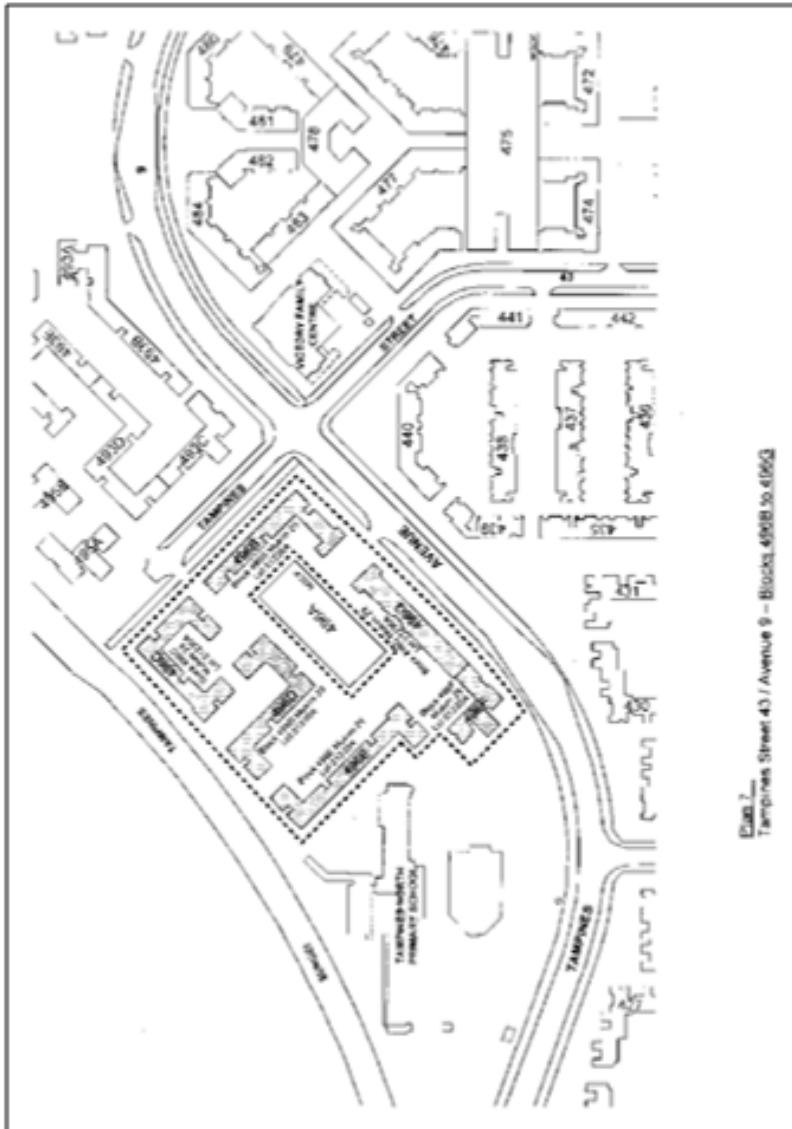

TAMPINES STREET 43/AVENUE 9

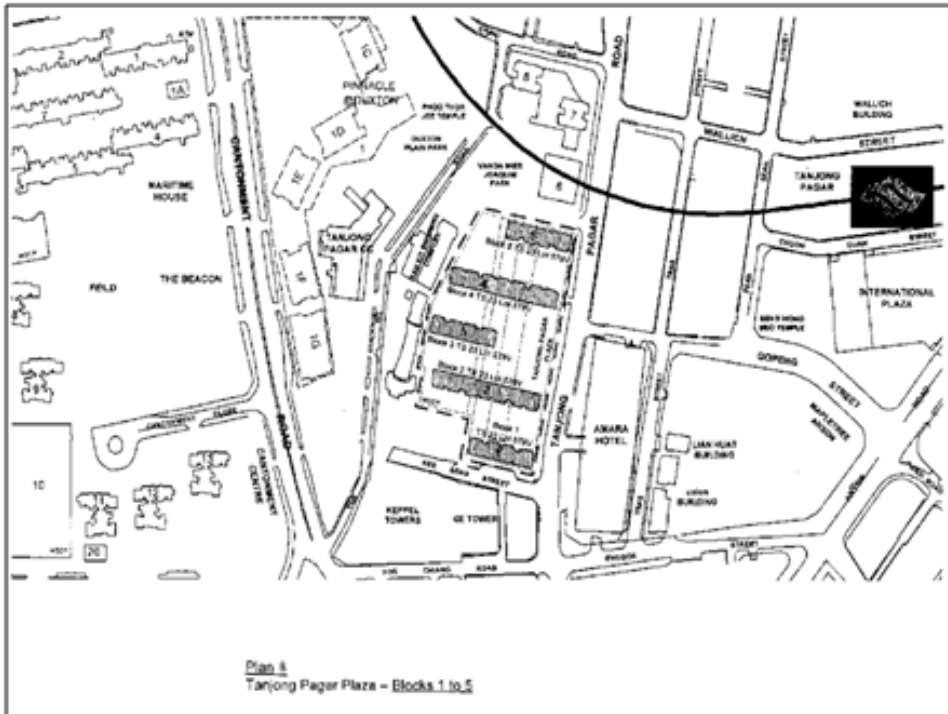
