In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 8) Order 2017 and comes into operation on 22 September 2017.

**Declaration of precincts for Home Improvement Programme**

2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

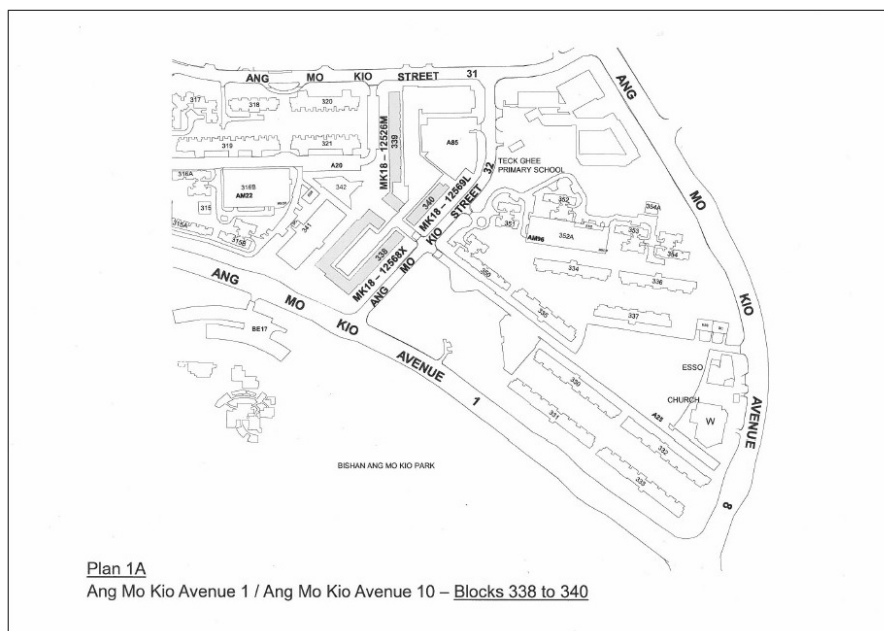
## THE SCHEDULE

1. All that part of the housing estate of the Board:

- (a) bounded by Ang Mo Kio Avenue 1, Ang Mo Kio Street 32 and Ang Mo Kio Street 31, comprised in Lot numbers 12568X, 12526M and 12569L in Mukim 18 and on which Apartment Blocks 338, 339 and 340 are erected, and which is more particularly shaded in Plan 1A;

### PLAN 1A

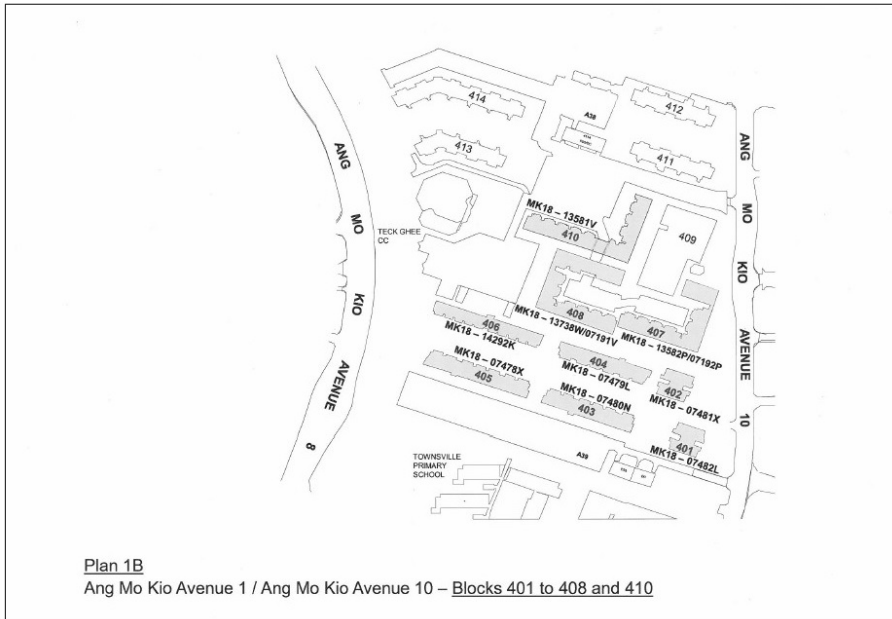
ANG MO KIO AVENUE 1/ANG MO KIO AVENUE 10



- (b) bounded by Ang Mo Kio Avenue 8 and Ang Mo Kio Avenue 10, comprised in Lot numbers 07482L, 07481X, 07480N, 07479L, 07478X, 14292K, 13582P/07192P, 13738W/07191V and 13581V in Mukim 18 and on which Apartment Blocks 401, 402, 403, 404, 405, 406, 407, 408 and 410 are erected, and which is more particularly shaded in Plan 1B.

### PLAN 1B

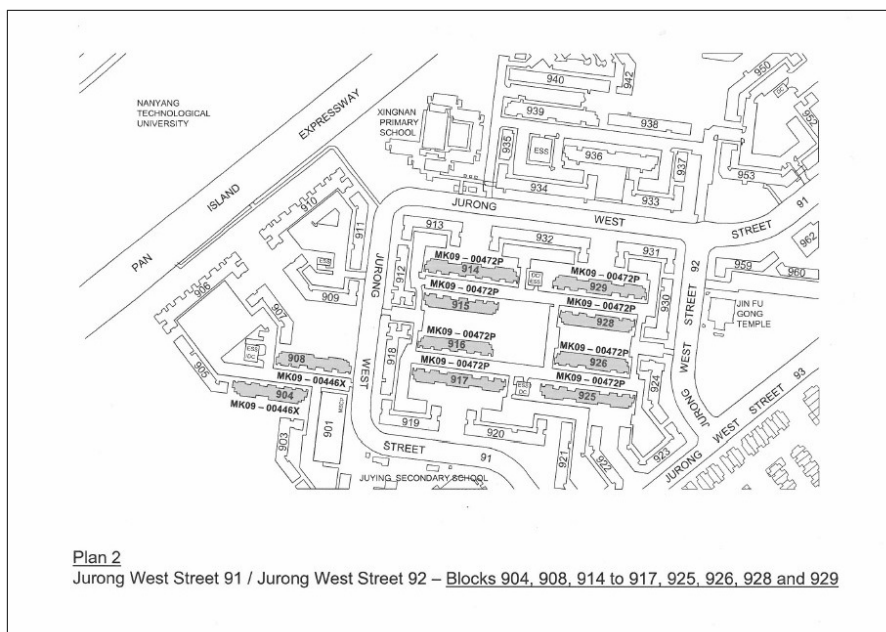
ANG MO KIO AVENUE 1/ANG MO KIO AVENUE 10

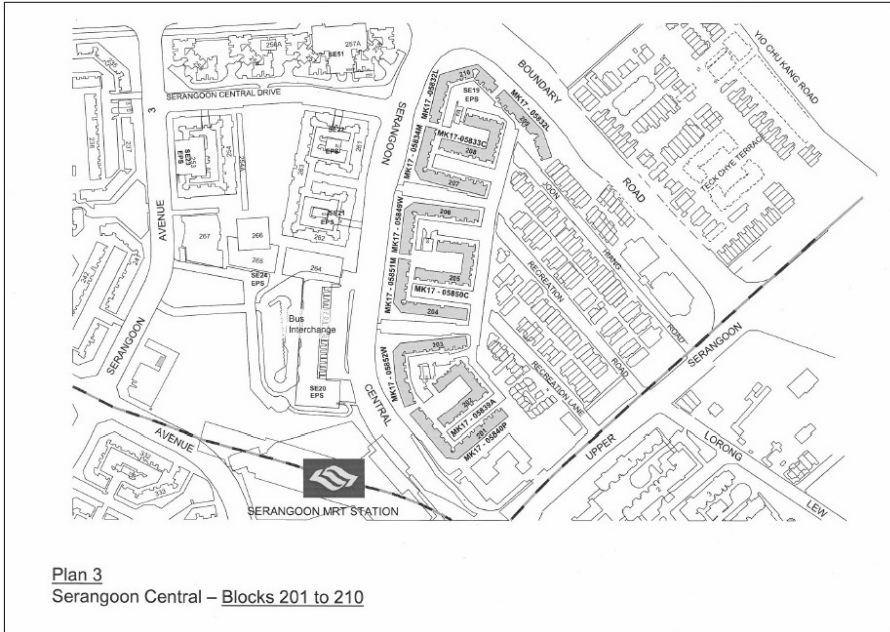
## JURONG WEST STREET 91/JURONG WEST STREET 92

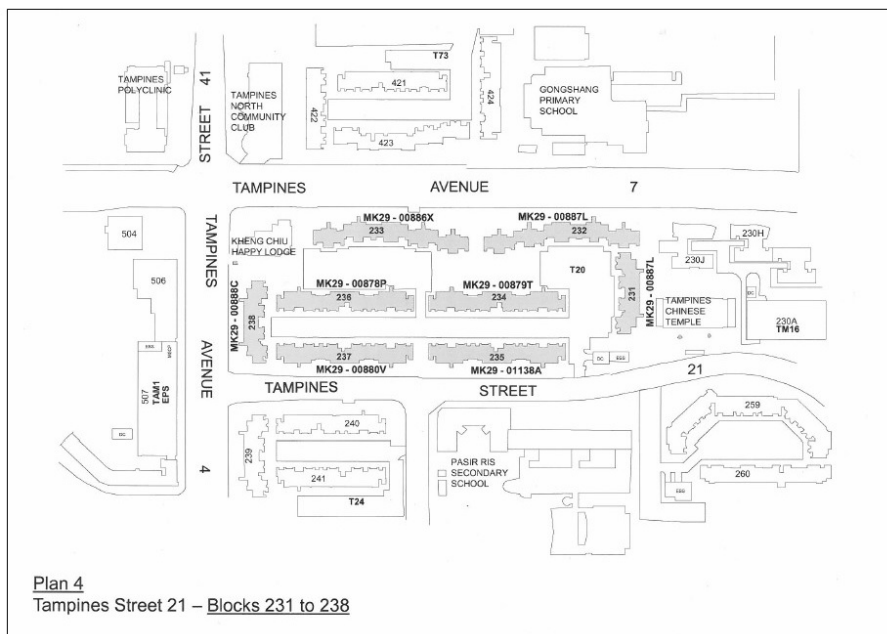

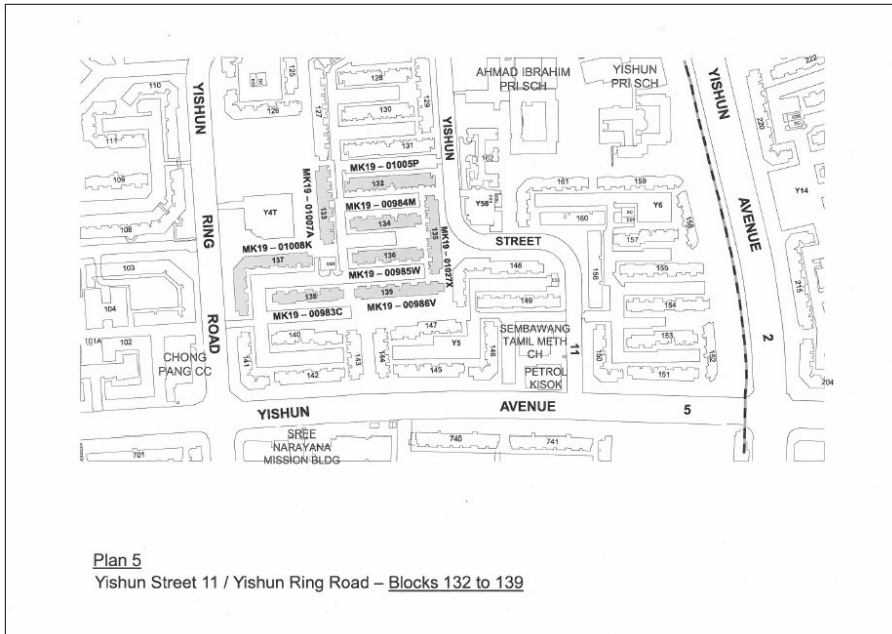
