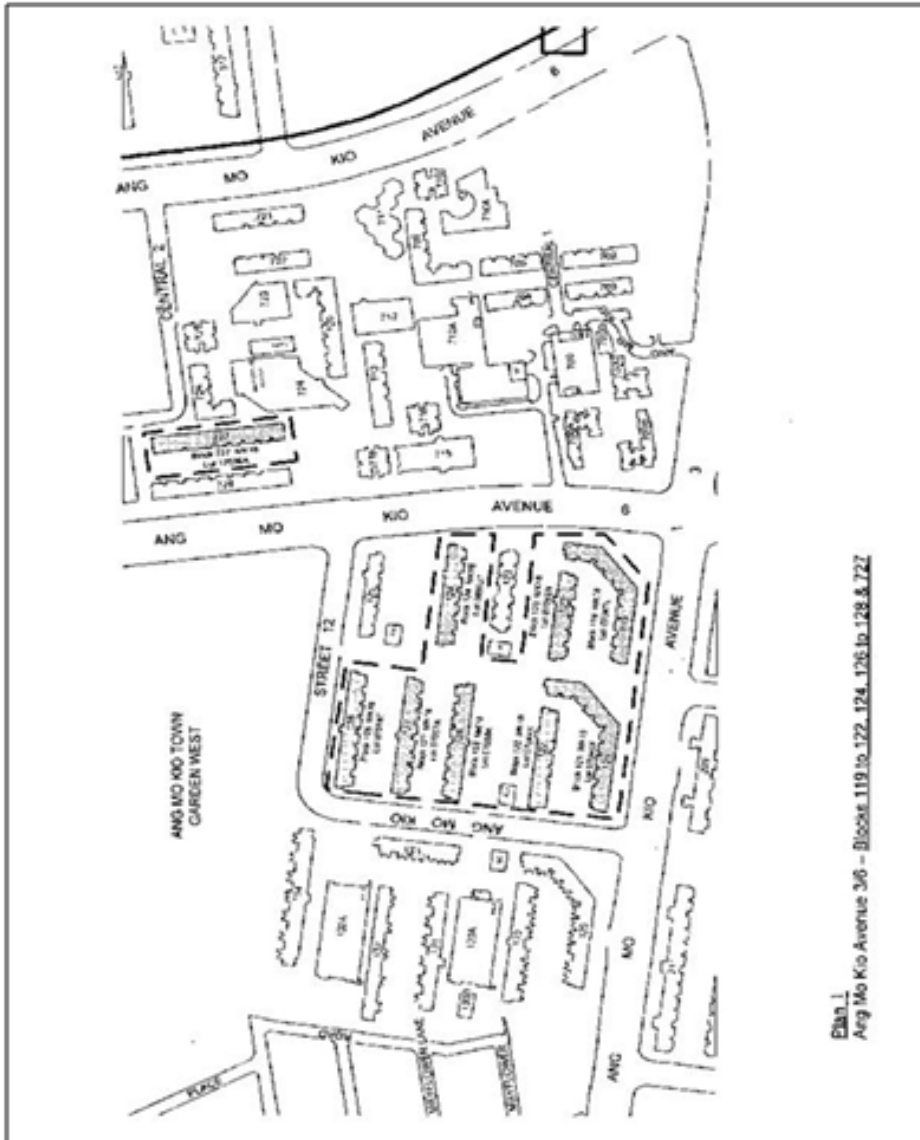

ANG MO KIO AVENUE 3/6



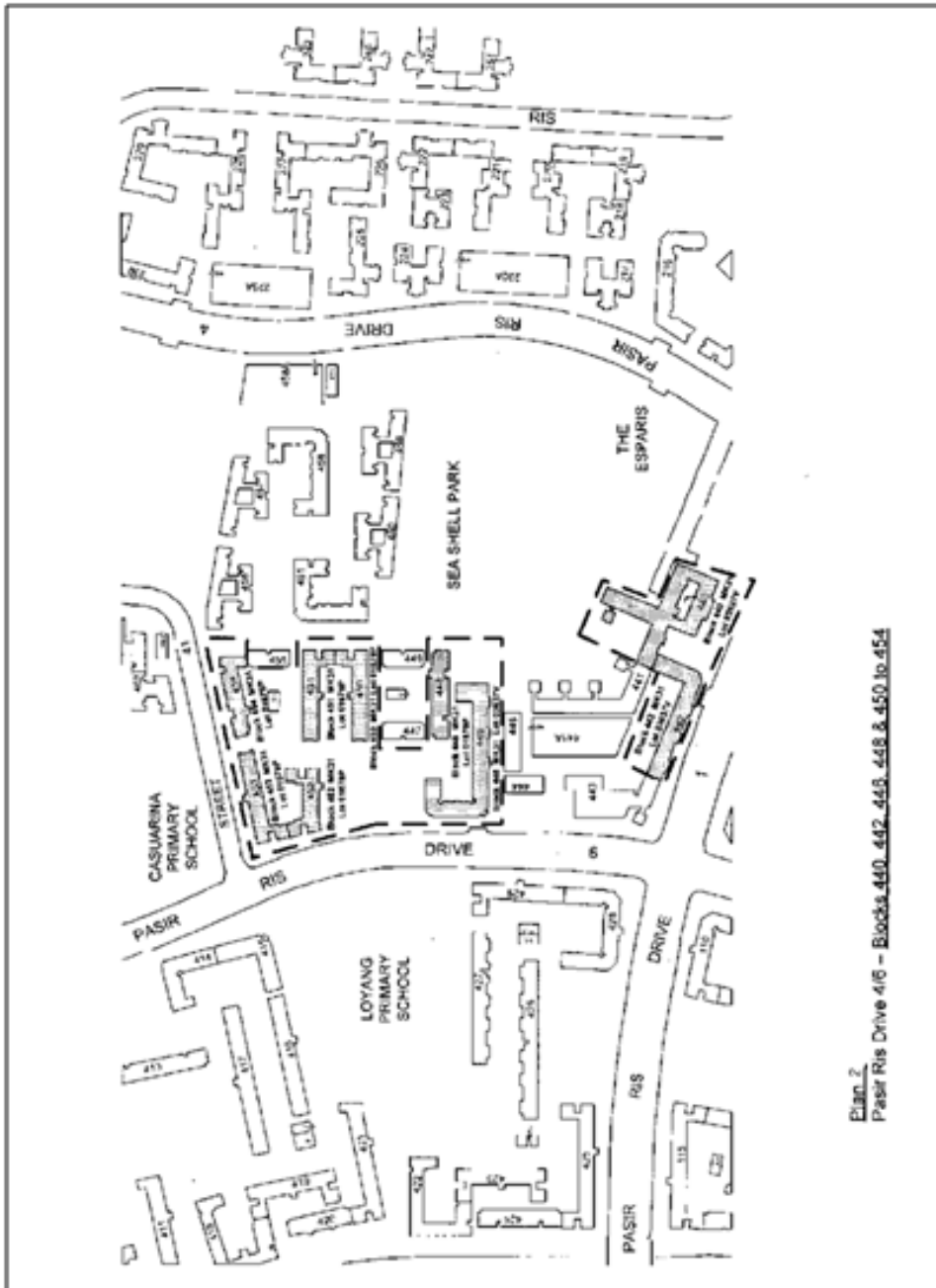
Plan 1

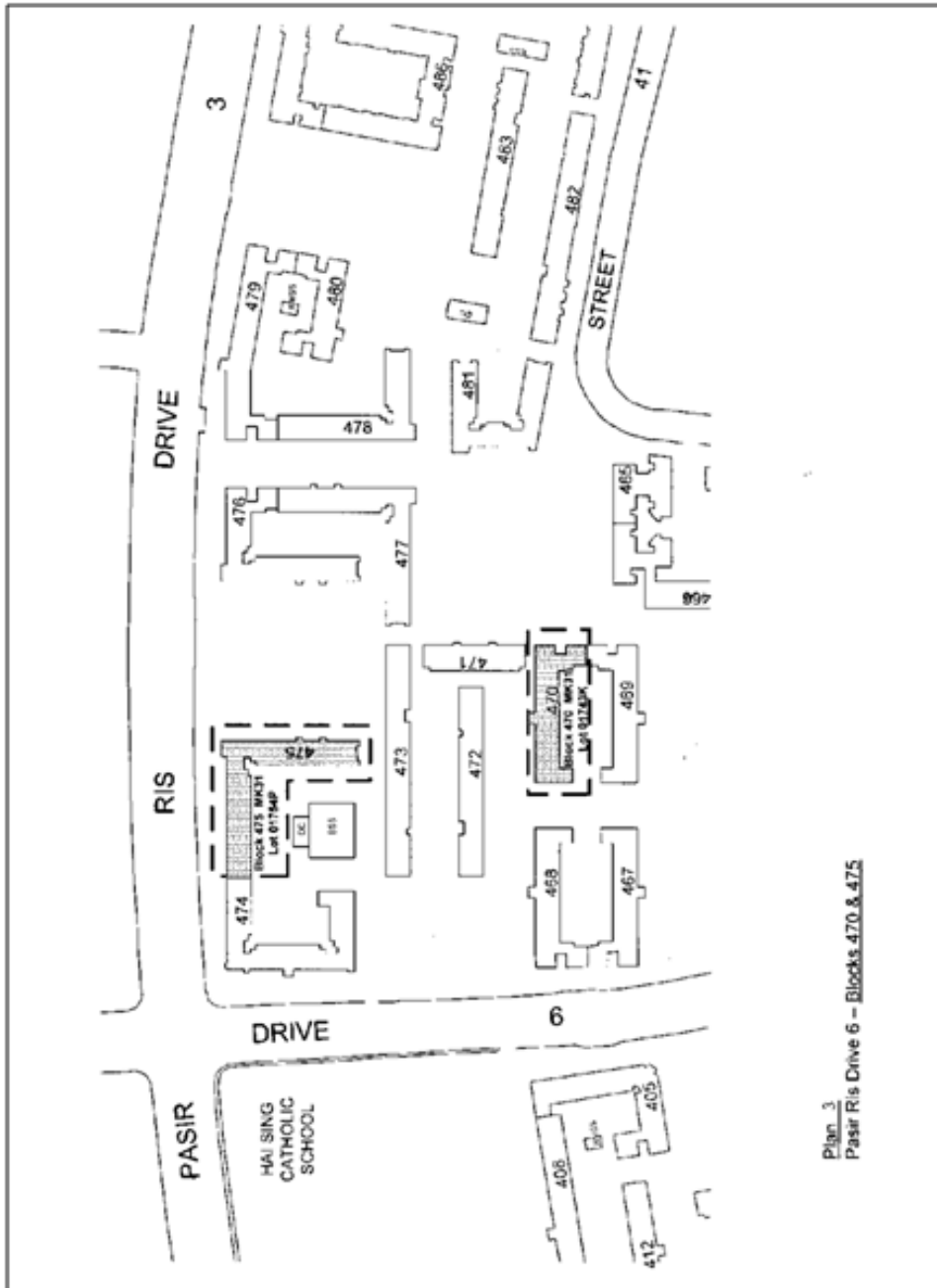

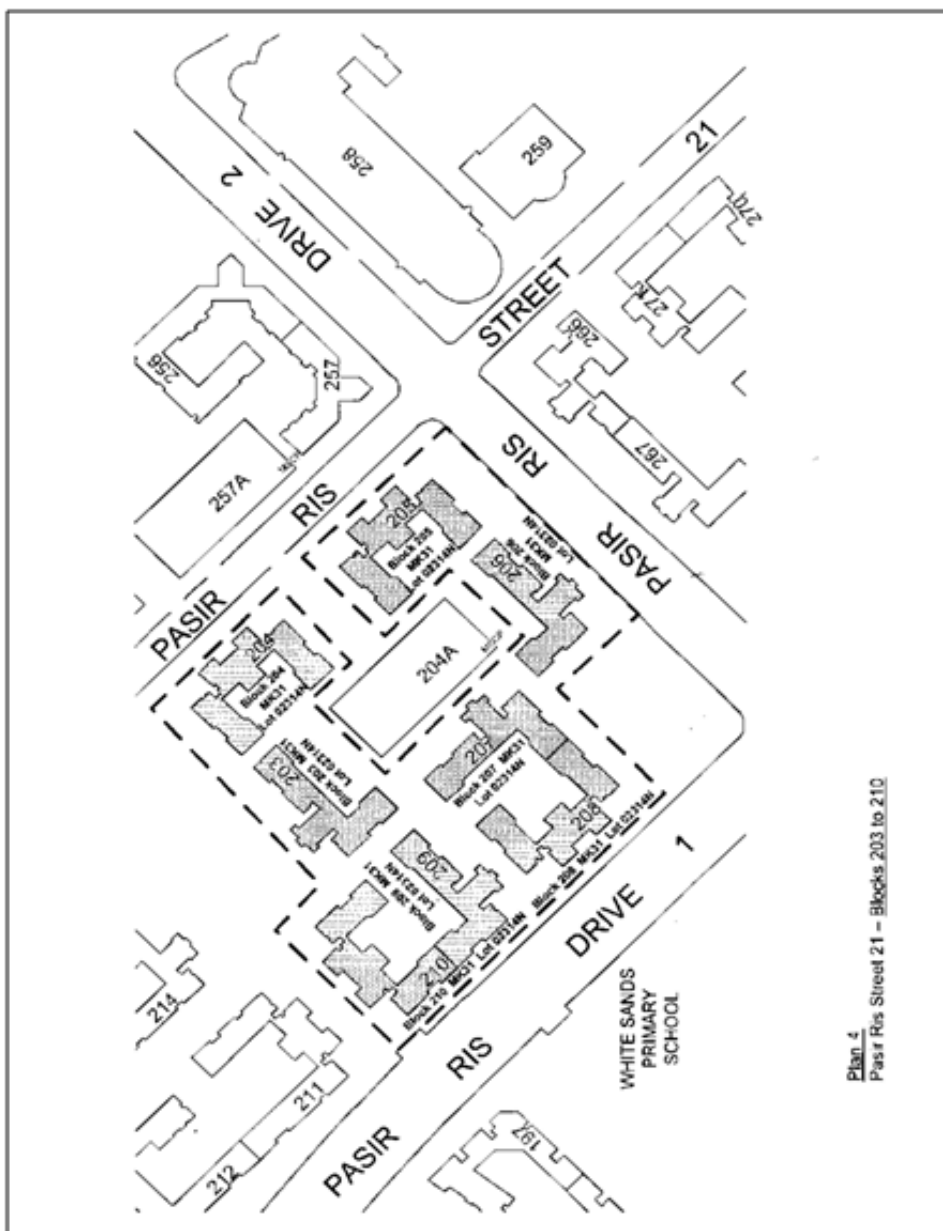

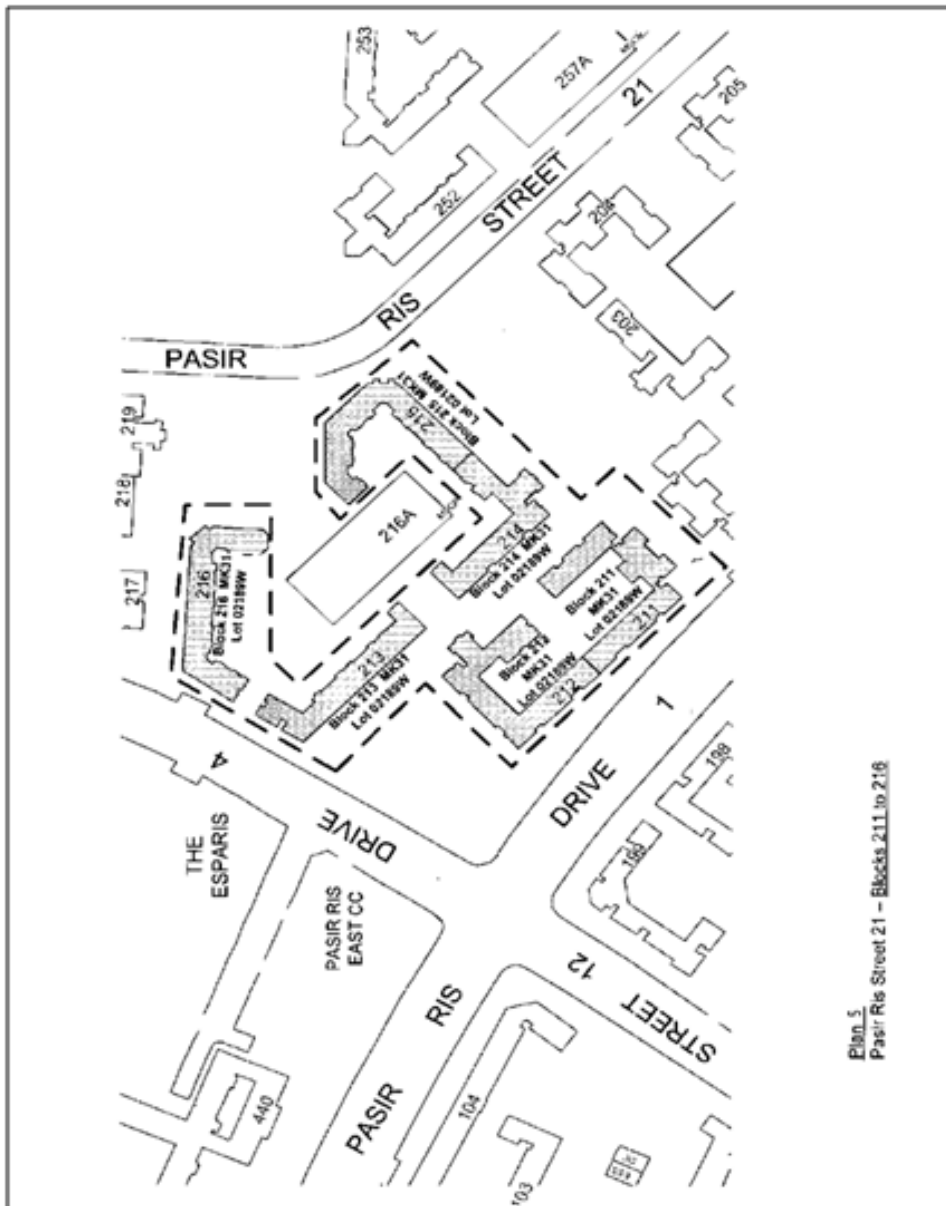

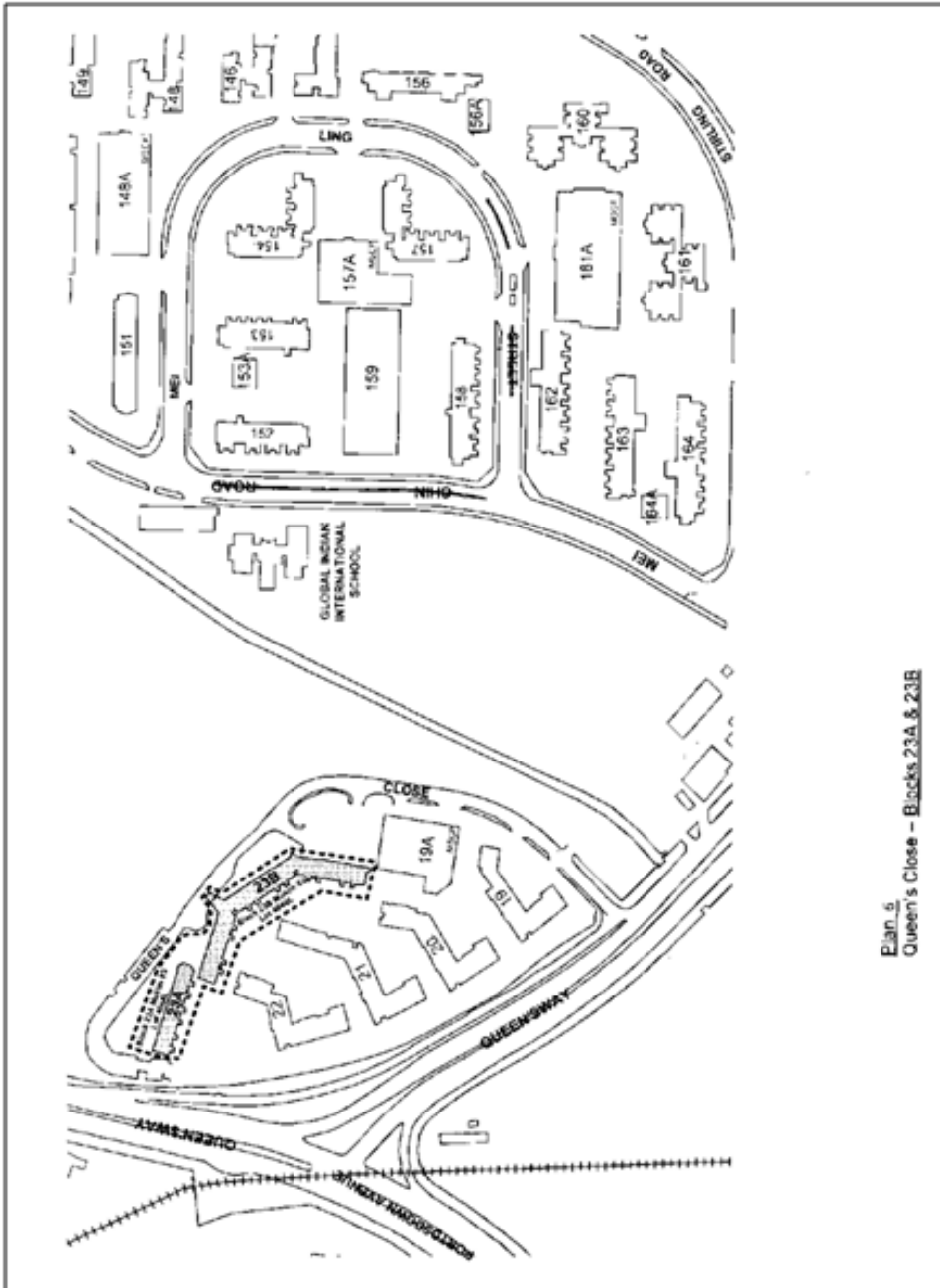

QUEEN'S CLOSE



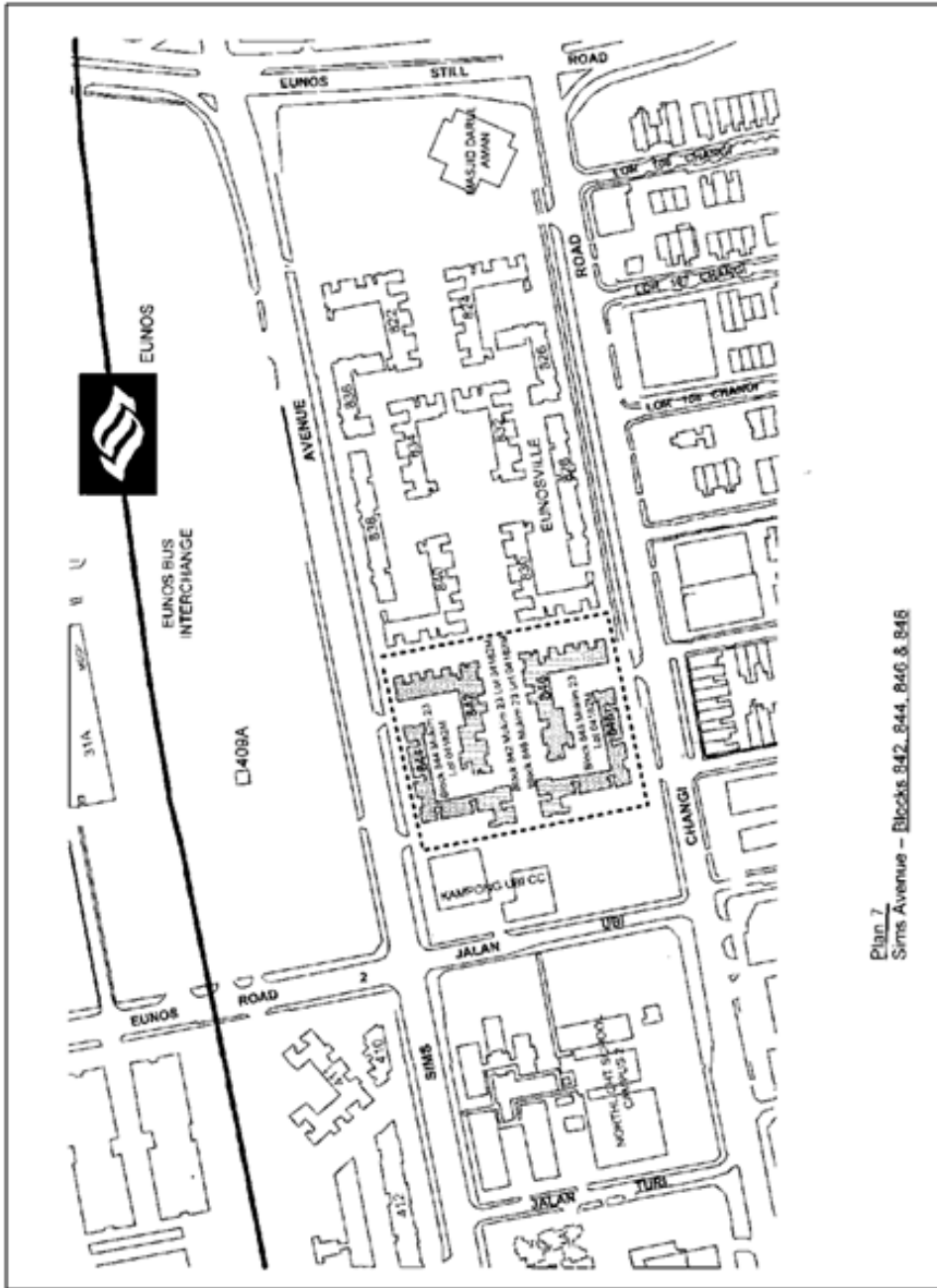
Plan 6

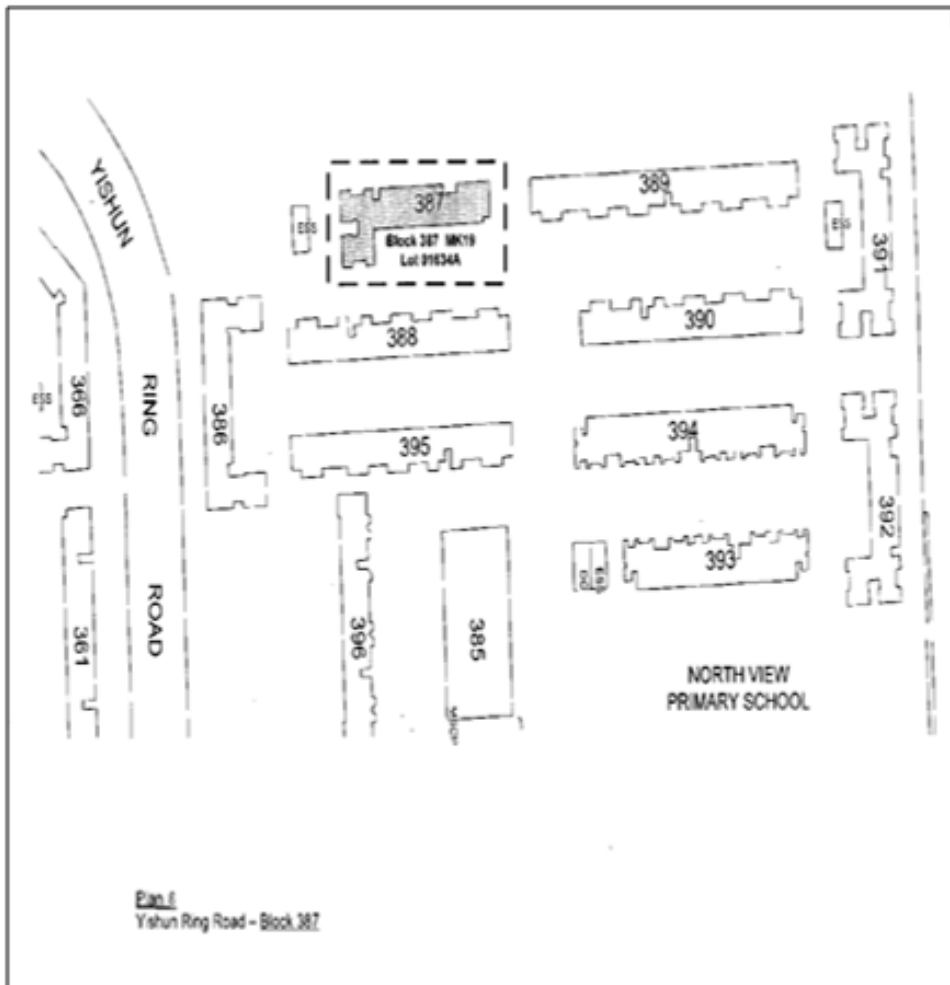
Plan 7
