In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 7) Order 2015 and comes into operation on 30 September 2015.

Declaration of precincts for Home Improvement Programme

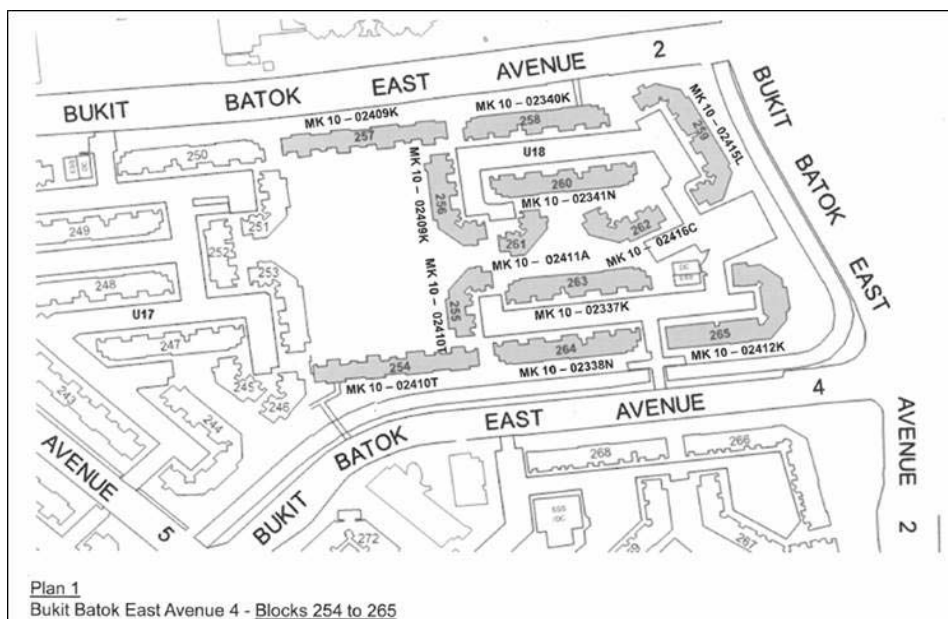
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Bukit Batok East Avenue 2 and Bukit Batok East Avenue 4, comprised in Lot numbers 02340K, 02415L, 02341N, 02411A, 02416C, 02337K, 02338N and 02412K in Mukim 10 and on which Apartment Blocks 258, 259, 260, 261, 262, 263, 264 and 265 are erected, in Lot number 02410T in Mukim 10 and on which Apartment Blocks 254 and 255 are erected, and in Lot number 02409K in Mukim 10 and on which Apartment Blocks 256 and 257 are erected, and which is more particularly shaded in Plan 1.

BUKIT BATOK EAST AVENUE 4

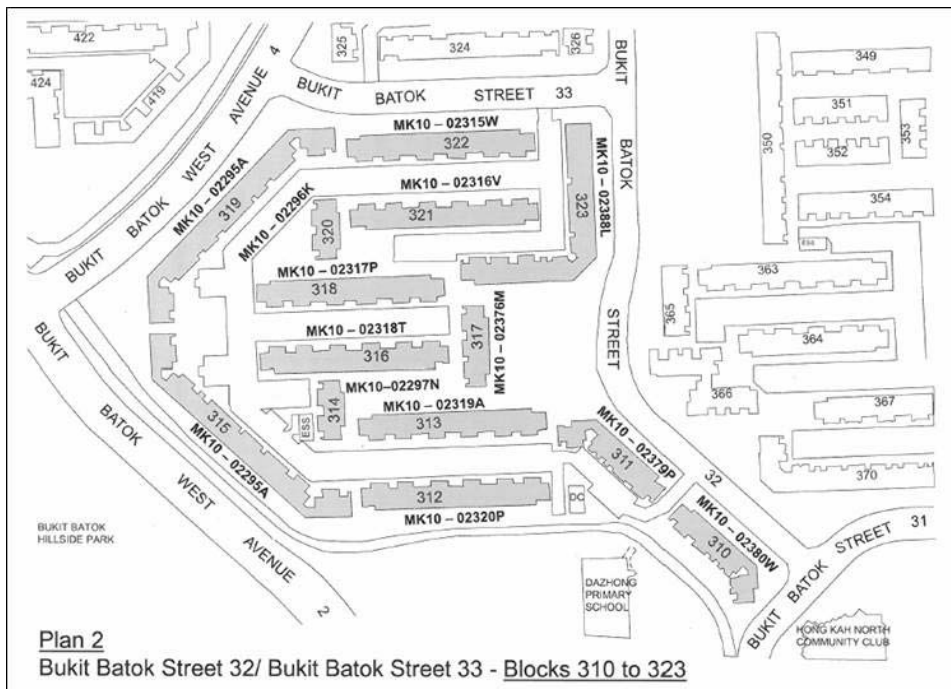

BUKIT BATOK STREET 32/BUKIT BATOK STREET 33

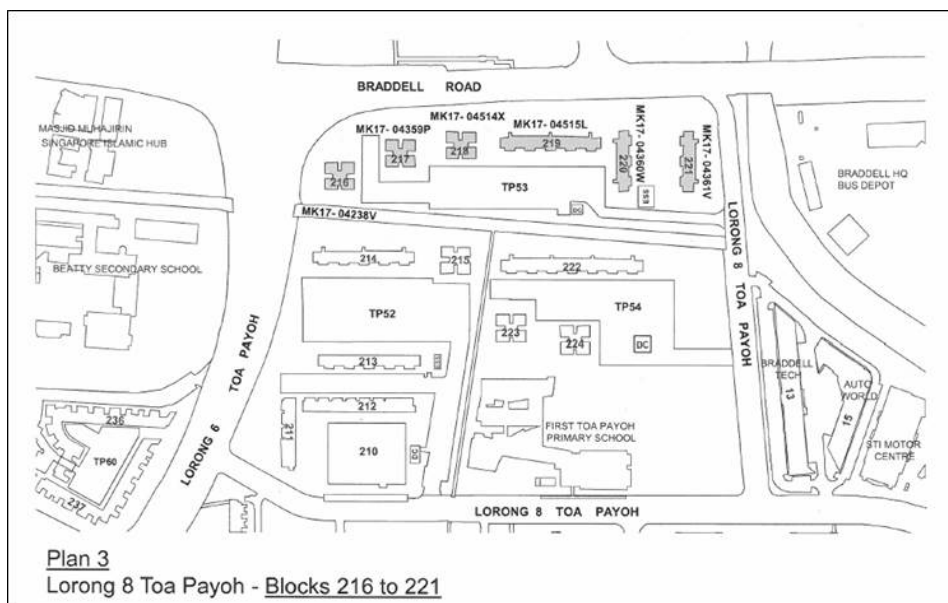

LORONG 8 TOA PAYOH

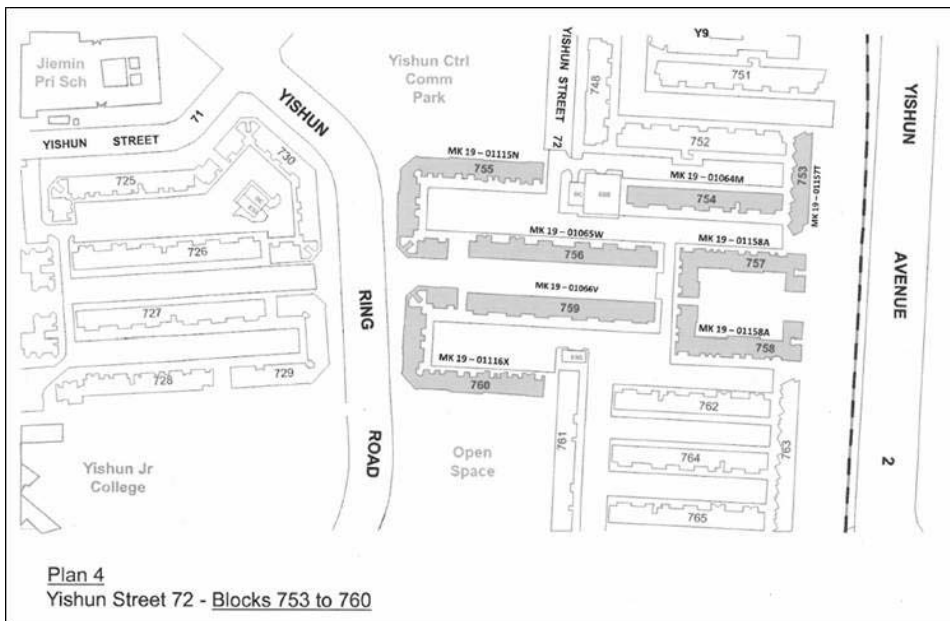
