Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 9) Order 2017 and comes into operation on 1 November 2017.

Declaration of precincts for Home Improvement Programme


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.





BISHAN STREET 12



BISHAN STREET 12



BUKIT BATOK STREET 21



HOUGANG AVENUE 10



JURONG WEST STREET 52


