Declaration of precincts for Home Improvement Programme




BEDOK NORTH AVENUE 4





CHOA CHU KANG AVENUE 3 / CHOA CHU KANG AVENUE 4



FAJAR ROAD / BUKIT PANJANG RING ROAD





HOUGANG AVENUE 8



PASIR RIS DRIVE 6



SERANGOON NORTH AVENUE 2



SPOTTISWOODE PARK ROAD



YISHUN CENTRAL 1


