In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

**Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 5) Order 2013 and shall come into operation on 16th October 2013.

**Declaration of precincts for Home Improvement Programme**

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

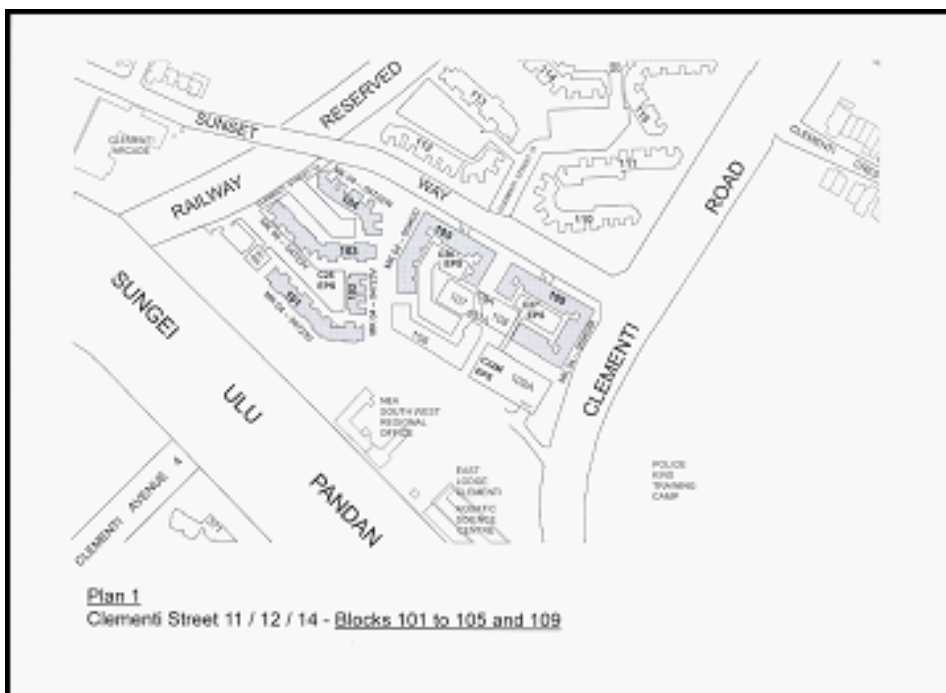

All that part of the housing estate of the Board at Clementi Street 11/12/14 comprised in Lot numbers 04722W, 05962C and 05963M in Mukim 04 and on which Apartment Blocks 104, 105 and 109 are erected, and in Lot number 04723V in Mukim 04 and on which Apartment Blocks 101, 102 and 103 are erected, and which is more particularly shaded in Plan 1.

### PLAN 1

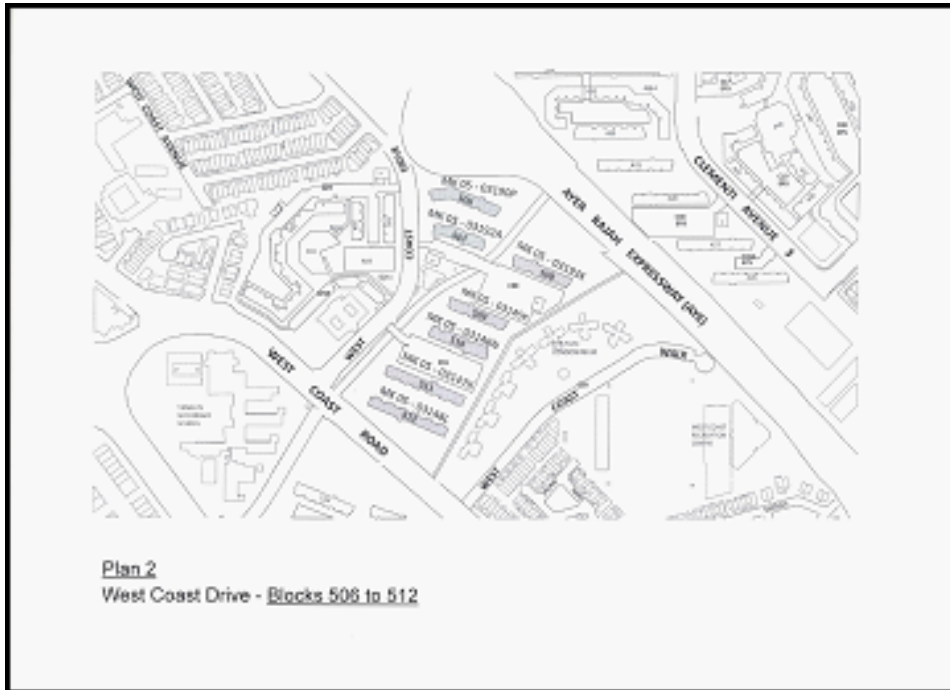
#### CLEMENTI STREET 11/12/14

### PLAN 2

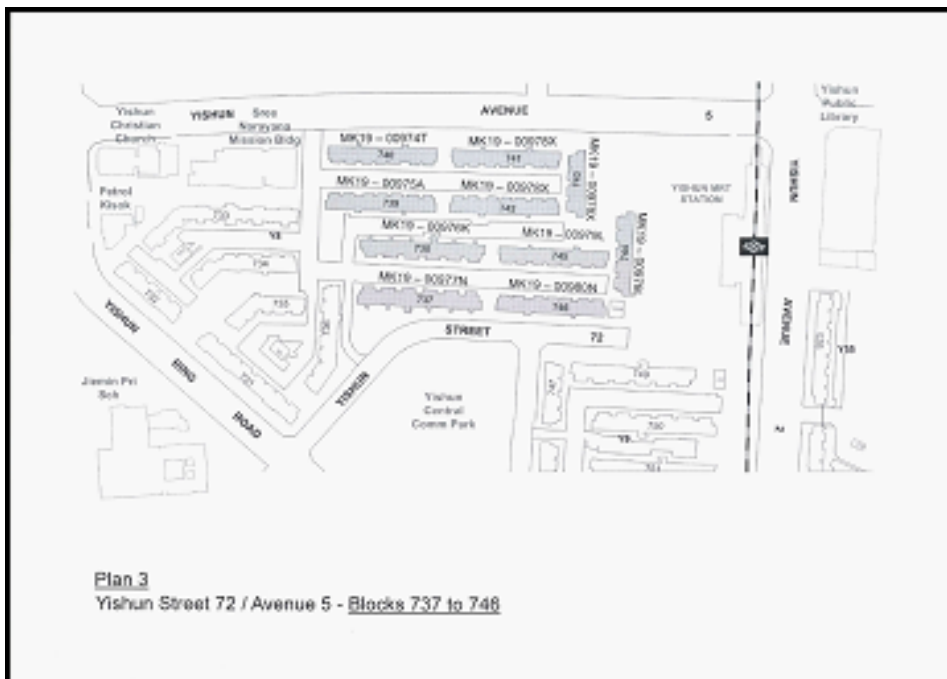
#### WEST COAST DRIVE
