Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 3) Order 2012 and shall come into operation on 21st February 2012.


Declaration of precincts for lift upgrading works

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.



JURONG WEST STREET 41



PLAN 4


JURONG WEST STREET 42
