Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 10) Order 2017 and comes into operation on 15 December 2017.

Declaration of precincts for Home Improvement Programme

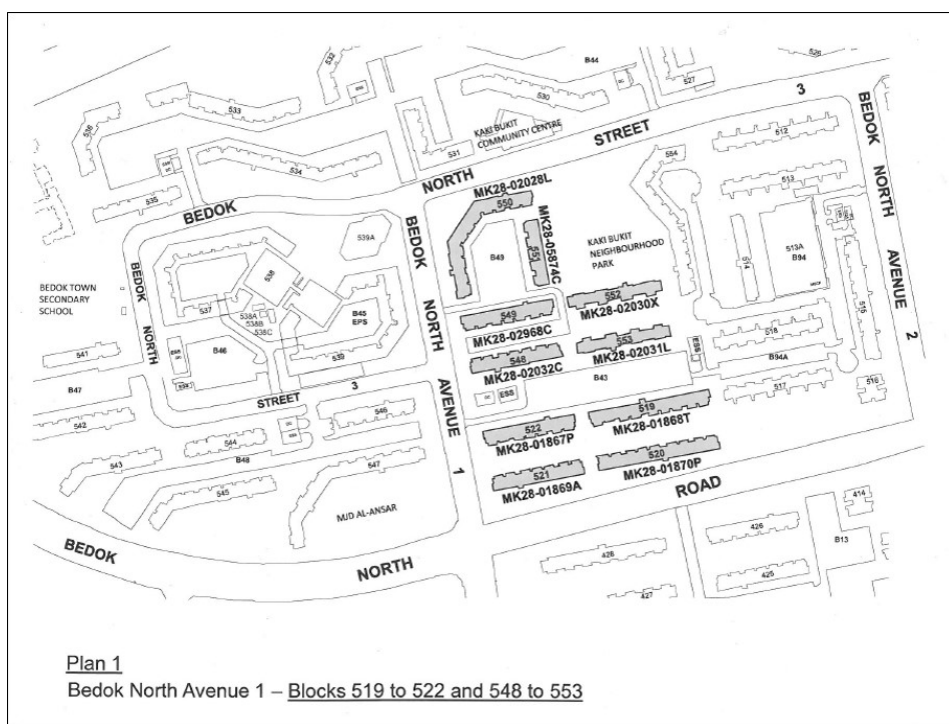
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

BEDOK NORTH AVENUE 1

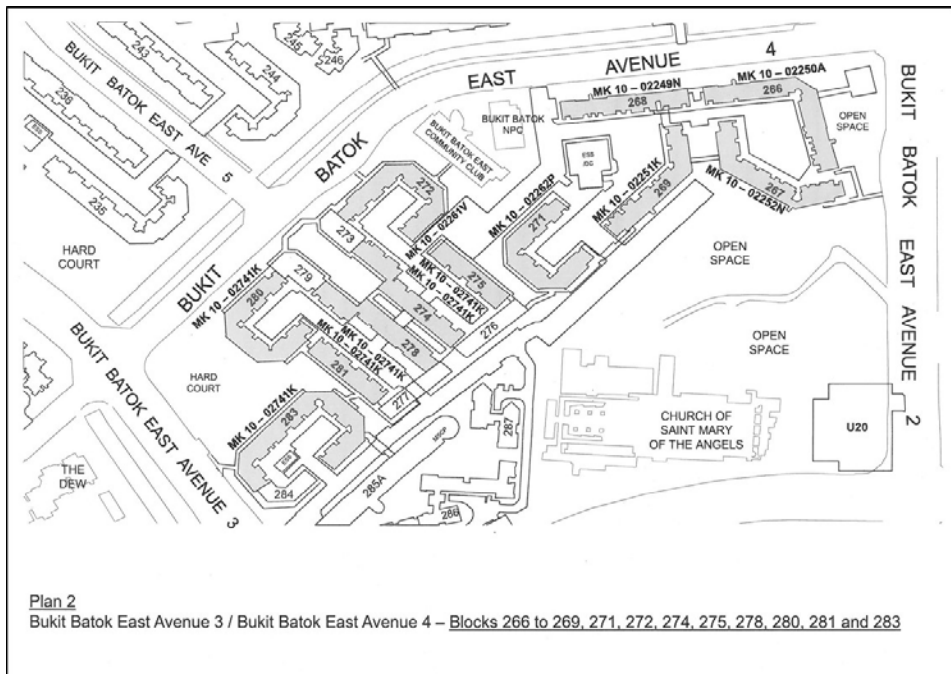

BUKIT BATOK EAST AVENUE 3/BUKIT BATOK EAST AVENUE 4

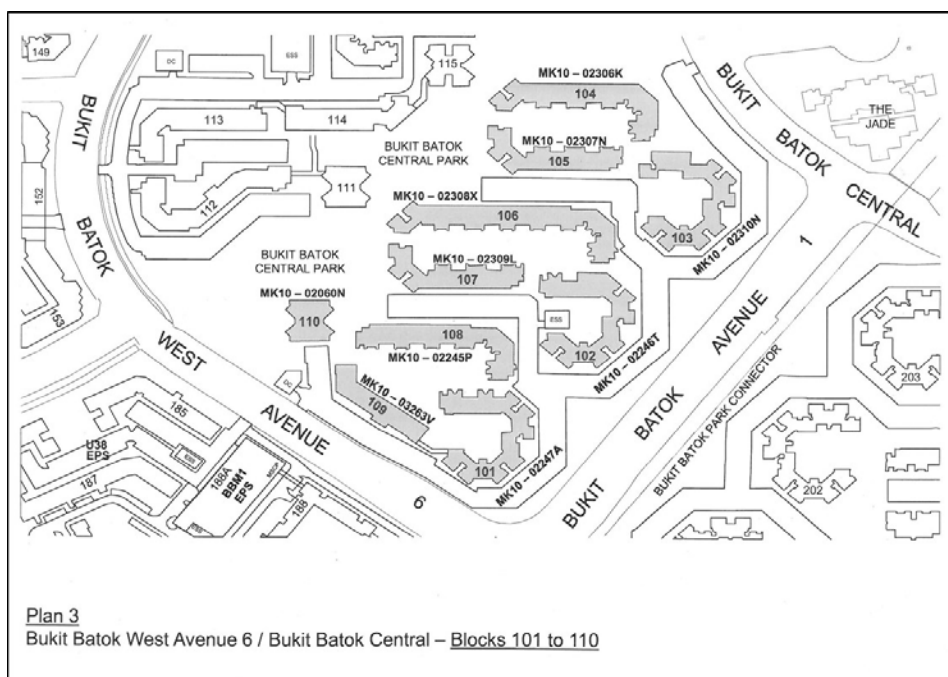

BUKIT BATOK WEST AVENUE 6/BUKIT BATOK CENTRAL

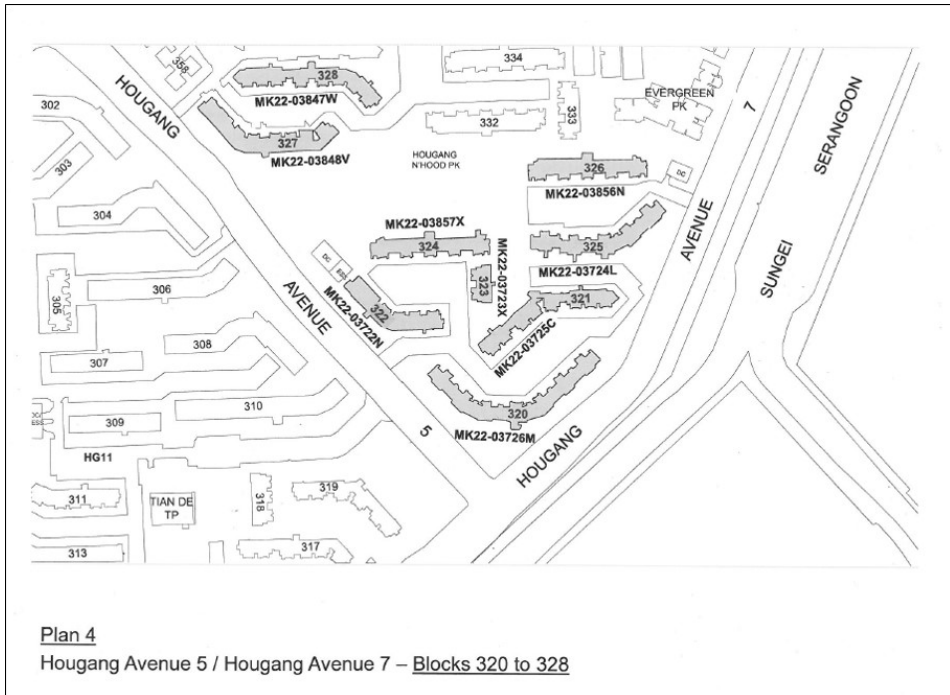

HOUGANG AVENUE 5/HOUGANG AVENUE 7

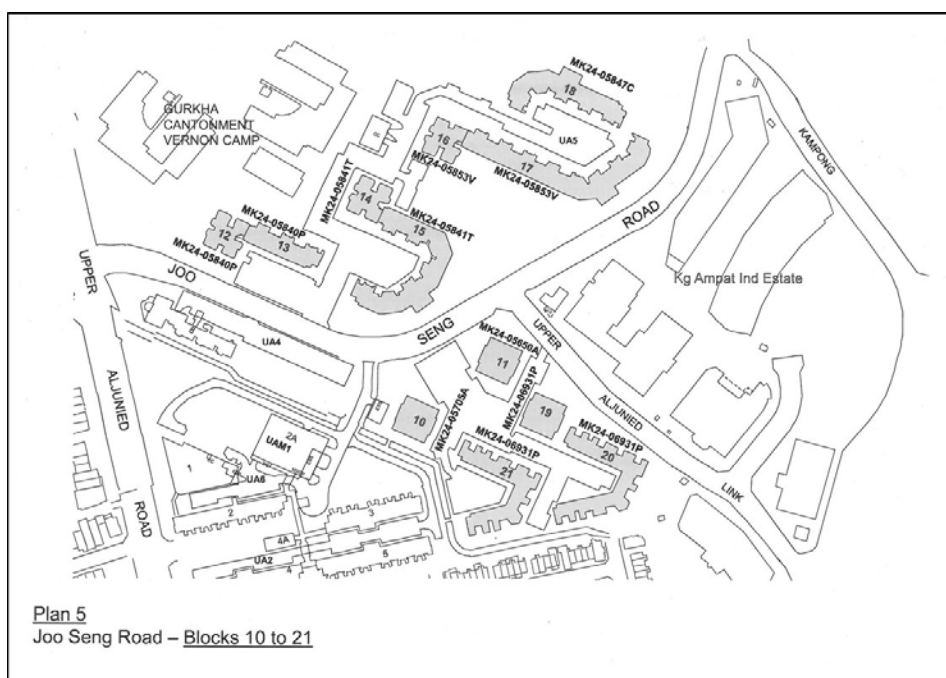

JOO SENG ROAD

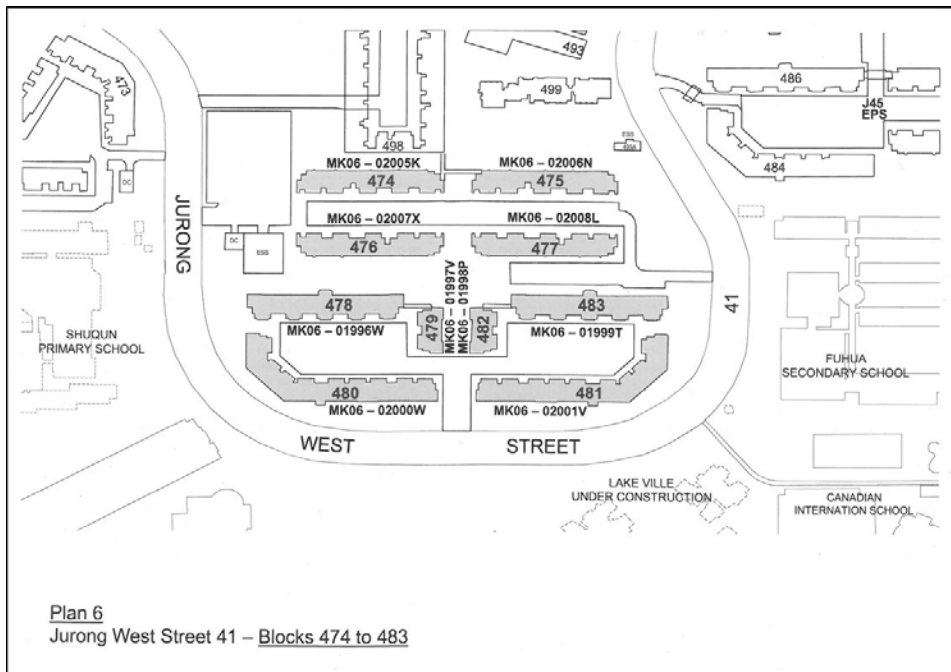

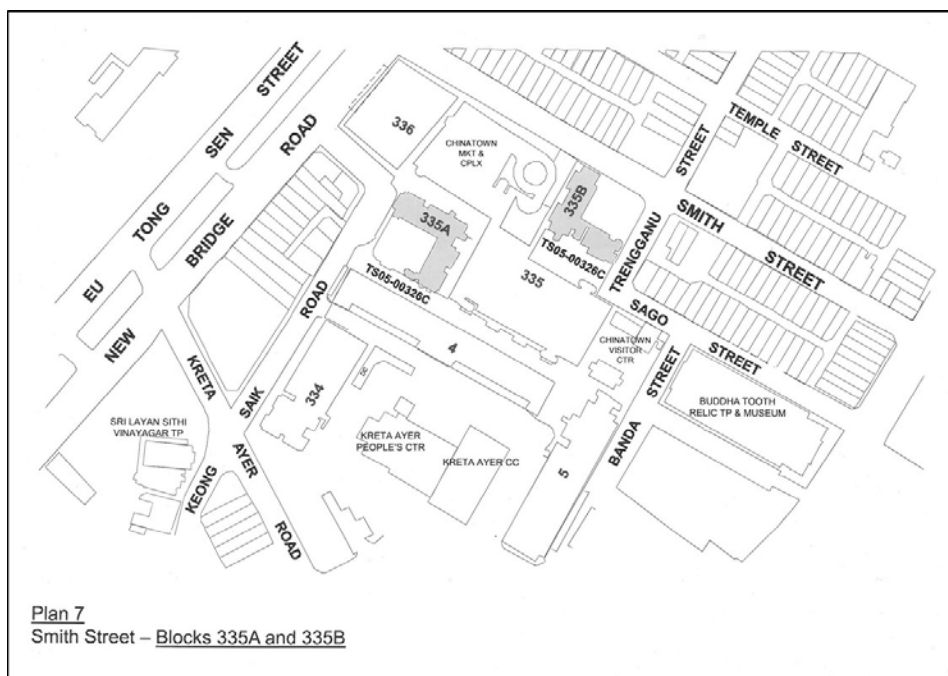
JURONG WEST STREET 41

SMITH STREET

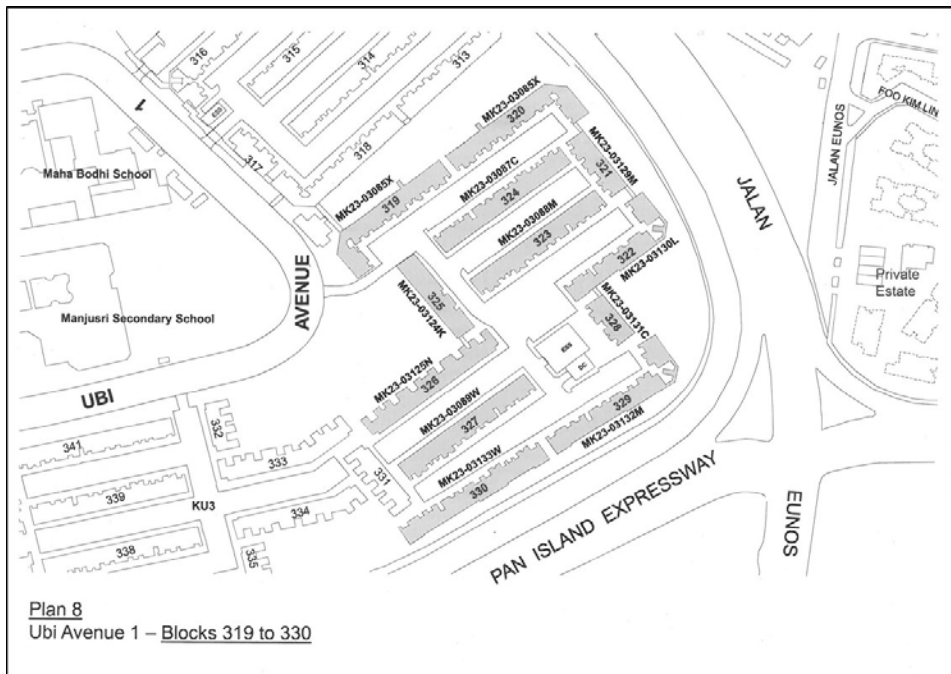
