1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 3) Order 2021 and comes into operation on 29 September 2021.

Declaration of precincts for Home Improvement Programme





BISHAN STREET 13



JURONG WEST STREET 73



KIM KEAT LINK / KIM KEAT AVENUE



LORONG 3 GEYLANG



SERANGOON AVENUE 3



TEBAN GARDENS ROAD



YISHUN CENTRAL / YISHUN RING ROAD



YISHUN RING ROAD / YISHUN AVENUE 11


