1. This Order is the Interpretation (Temporary Suspension of Electronic Road Pricing System Charges) Order 2019.

Temporary suspension of charges

- 2.—(1) For the period 18 September 2019 to 20 September 2019 (both dates inclusive), the road-user charges payable under the First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) (called the principal Rules) in respect of any motor vehicle ridden, driven or moved into a specified entry point on a specified road set out in Part 1 of the Schedule are wholly remitted during the restricted hours as specified opposite in the second column.
- (2) For the period 18 September 2019 to 21 September 2019 (both dates inclusive), the road-user charges payable under the

First Schedule to the principal Rules in respect of any motor vehicle ridden, driven or moved into a specified entry point on a specified road set out in Part 2 of the Schedule are wholly remitted during the restricted hours as specified opposite in the second column.
