**1.** This Order may be cited as the Protected Areas (Consolidation) Order.

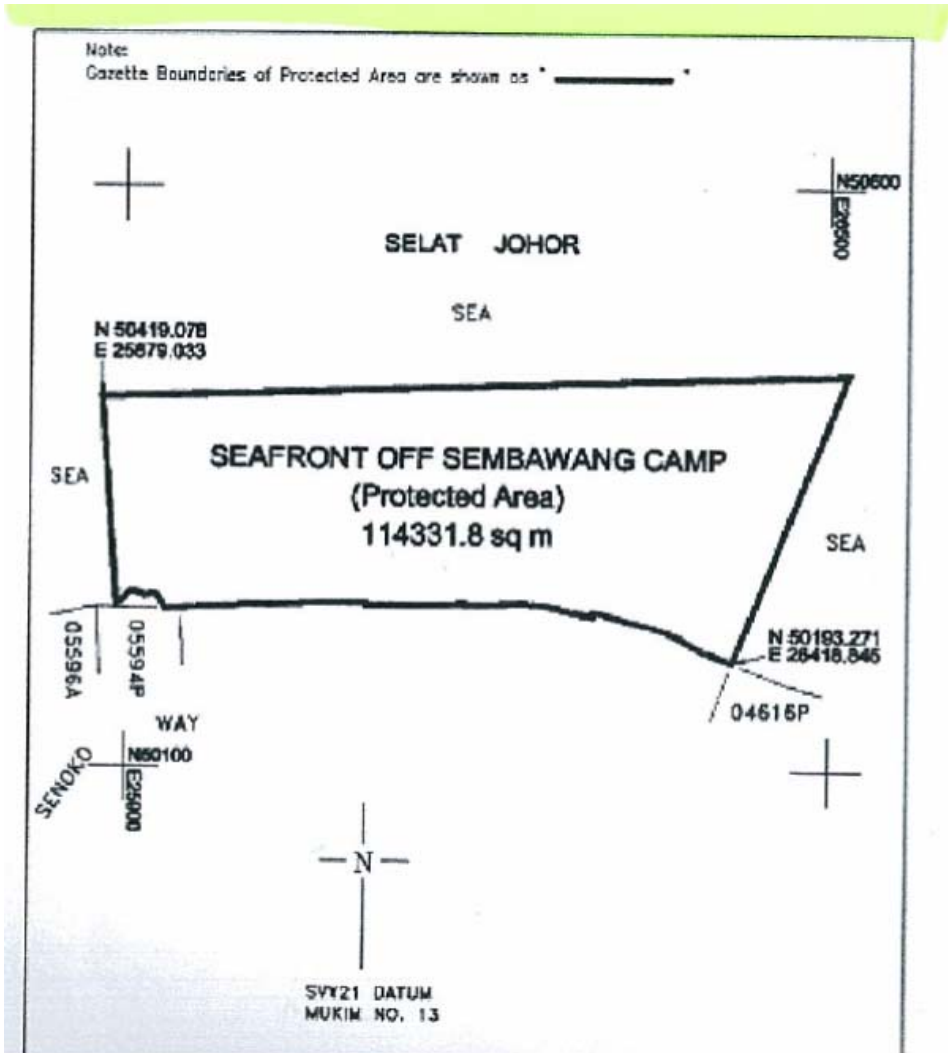

1. TUAS JETTY — Area A

The boundary is bounded by a circle of radius 60 metres with the centre of co-ordinates 30,326.2 metres North and 4,141.0 metres East of the Survey Department origin of co-ordinates (30,000 metres North and 30,000 metres East) located at the southwest end of the slipway.

2. TUAS JETTY — Area B

Commencing at a point of co-ordinates 29,937.5 metres North and 3,622.8 metres East of the Survey Department origin of co-ordinates (30,000 metres North and 30,000 metres East), the boundaries run clock-wise along an arc of semi-circle of radius 200 metres, thence along a line on a bearing  $337^{\circ} 29'$  for a distance of 132.0 metres approximately, thence clock-wise along an arc of semi-circle of radius 200 metres and thence along a line on a bearing  $157^{\circ} 29'$  for a distance of 132.0 metres approximately to the point of commencement.

3. TUAS JETTY — Area C

Commencing at a point of co-ordinates 30,014.0 metres North and 3,807.6 metres East of the Survey Department origin of co-ordinates (30,000 metres North and 30,000 metres East), the boundaries run clock-wise along an arc of semi-circle of radius 400 metres, thence along a line on a bearing of  $337^{\circ} 29'$  for a distance of 132.0 metres approximately, thence clock-wise along an arc of semi-circle of radius 400 metres and thence along a line on a bearing of  $157^{\circ} 29'$  for a distance of 132.0 metres approximately to the point of commencement.

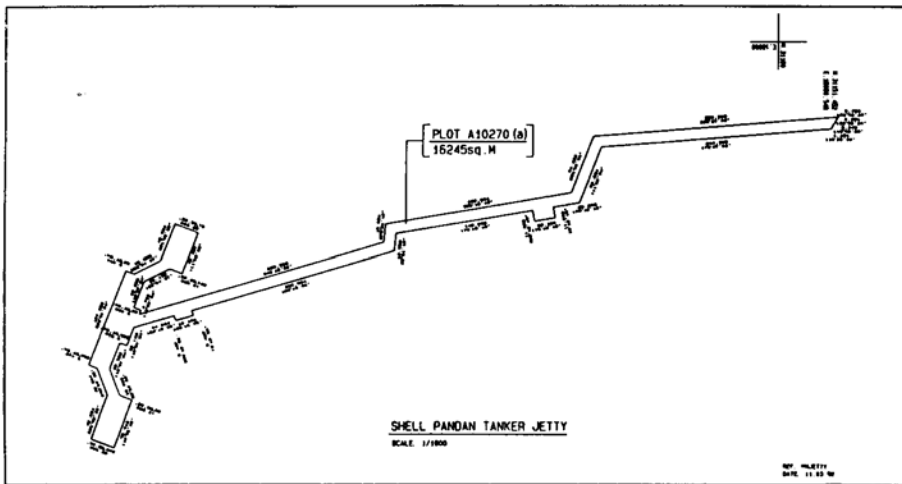
