The Schedule

**1.** This Order may be cited as the Protected Areas (Consolidation) Order.

**2.** The areas described in the Schedule are hereby declared to be protected areas for the purposes of the Protected Areas and Protected Places Act, and every person who is in those areas shall comply with such directions for regulating his movement and conduct as may be given by an authorised officer.

**(1) PULAU SERAYA POWER STATION STAGE II INTAKE STRUCTURE**

All that area comprised of lots 378,333 part and 381 part Mukim 34 occupied by “PULAU SERAYA POWER STATION STAGE II INTAKE STRUCTURE” containing an area of approximately 3,354 square metres and bounded approximately as follows:

Commencing at the northernmost corner of the aforesaid “PULAU SERAYA POWER STATION STAGE II INTAKE STRUCTURE” which point is 29,225.3 metres North and 16,580.1 metres East of the Survey Department origin of co-ordinates (30,000 metres North, 30,000 metres East), the boundaries run as follows:

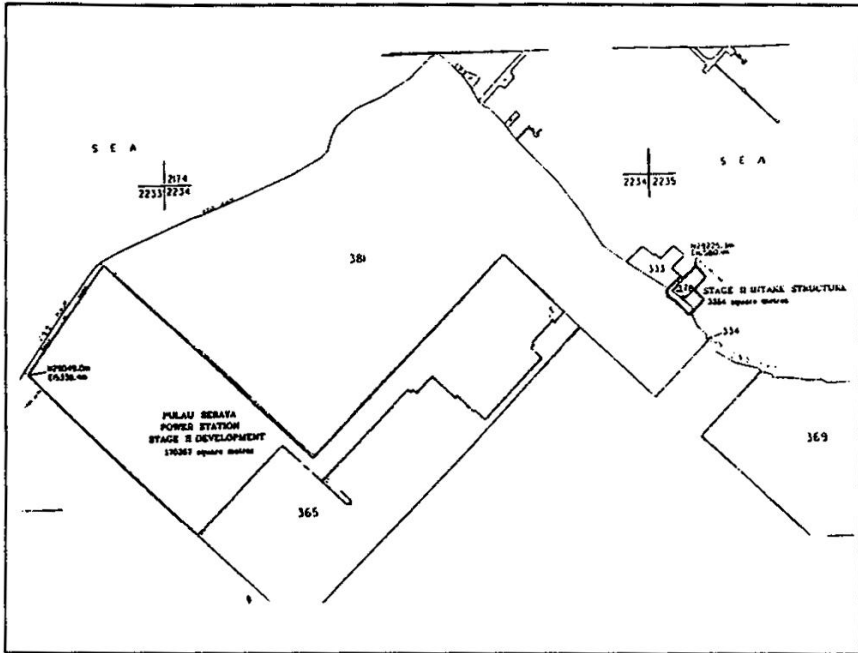

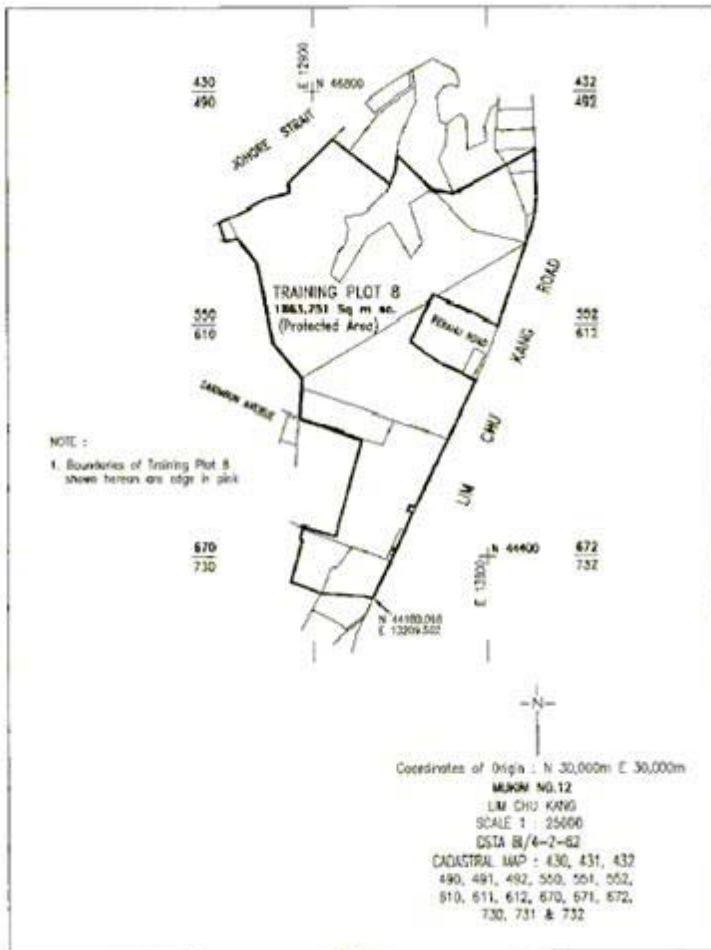
