## PROTECTED PLACES (NO. 2) ORDER 2016

#### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 5(1) of the Protected Areas and Protected Places Act, the Minister for Home Affairs makes the following Order:

#### Citation and commencement

1. This Order is the Protected Places (No. 2) Order 2016 and comes into operation on 24 March 2016.

# Premises declared to be protected place

- **2.**—(1) The premises described in the second column of the Schedule are declared to be a protected place for the purposes of the Act.
- (2) No person may enter or remain in those premises unless the person
  - (a) is in possession of a pass-card or permit issued by the authority specified in the first column of the Schedule; or
  - (b) has received the permission of an authorised officer on duty at those premises to enter those premises.

## Amendment of Protected Places (Consolidation) Order

**3.** Item (12) of the Schedule to the Protected Places (Consolidation) Order (O 14) is deleted.


