INFRASTRUCTURE PROTECTION (PROTECTED PLACES) (NO. 2) ORDER 2021

In exercise of the powers conferred by sections 14(1) and 19(1) of the Infrastructure Protection Act 2017, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order is the Infrastructure Protection (Protected Places) (No. 2) Order 2021 and comes into operation on 26 March 2021.

Premises declared to be protected places

2. The premises described in the second column of the Schedule are declared to be protected places for the purposes of the Act, and the person specified in the first column of that Schedule is designated as the authority of the corresponding protected place.

Revocations

3.—(1) Paragraphs 1, 2, 5, 6 and 7 of item (1), item (7), paragraph 1 of item (9), and items (27), (54), (81), (83) and (92) of the Schedule to the Protected Places (Consolidation) Order (O 2) are deleted.

(2) Paragraphs (1), (3) and (4) of item (4) of the Schedule to the Protected Places (Consolidation) Order (O 8) are deleted.

(3) Item (2) of the Schedule to the Protected Places (Consolidation) Order (O 13) is deleted.






