INFRASTRUCTURE PROTECTION (PROTECTED PLACES) ORDER 2022

In exercise of the powers conferred by sections 14(1) and 19(1) of the Infrastructure Protection Act 2017, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order is the Infrastructure Protection (Protected Places) Order 2022 and comes into operation on 25 January 2022.

Premises declared to be protected place

2. The premises described in the second column of the Schedule are declared to be a protected place for the purposes of the Act, and the person specified in the first column of that Schedule is designated as the authority of the protected place.

Revocations

3.—(1) The Protected Places Order 2018 (G.N. No. S 132/2018) is revoked.

(2) The Protected Places (No. 5) Order 2018 (G.N. No. S 468/2018) is revoked.

(3) Item 2 of the Schedule to the Infrastructure Protection (Protected Places) (No. 16) Order 2020 (G.N. No. S 999/2020) is deleted.
