1. This Order is the Infrastructure Protection (Protected Places) (No. 4) Order 2022 and comes into operation on 31 January 2022.

2. The premises described in the second column of the Schedule are declared to be a protected place for the purposes of the Act, and the person specified in the first column of that Schedule is designated as the authority of the protected place.


