# PROTECTED AREAS AND PROTECTED PLACES ACT (CHAPTER 256)

## PROTECTED PLACES (NO. 9) ORDER 2014

### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 5(1) of the Protected Areas and Protected Places Act, the Minister for Home Affairs hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Protected Places (No. 9) Order 2014 and shall come into operation on 19 September 2014.

#### **Premises declared to be protected place**

2.—(1) The premises described in the second column of the Schedule are hereby declared to be a protected place for the purposes of the Act.

(2) No person shall be in those premises unless he —

- (a) is in possession of a pass-card or permit issued by the authority specified in the first column of the Schedule; or
- (b) has received the permission of an authorised officer on duty at those premises to enter those premises.


