# INFRASTRUCTURE PROTECTION (PROTECTED AREAS) ORDER 2024

### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by sections 8(1) and 13(1) of the Infrastructure Protection Act 2017, the Minister for Home Affairs makes the following Order:

### **Citation and commencement**

**1.** This Order is the Infrastructure Protection (Protected Areas) Order 2024 and comes into operation on 30 September 2024.

# Premises declared to be protected area and surrounding area

**2.**—(1) The premises described in the second column of Part 1 of the Schedule are declared to be a protected area for the purposes of the Act, and the person specified in the first column of Part 1 of that Schedule is designated as the authority of the protected area.

(2) The premises described in Part 2 of the Schedule are specified to be the surrounding area of the protected area for the purposes of sections 27 and 28 of the Act.

# Revocation

**3.** Revoke the Protected Areas (No. 2) Order 2005 (G.N. No. S 328/2005).






(a) all that area occupied by "Second Link Bridge", the boundaries of which are more particularly delineated in the map set out below;
