Citation

1. These Regulations may be cited as the Maritime and Port Authority of Singapore (Composition of Offences) Regulations.

Composition of offences

2. Any of the offences specified in —
- (a) Part I of the Schedule may be compounded for a sum not exceeding \$500;
 - (b) Part II of the Schedule may be compounded for a sum not exceeding \$200; and
 - (c) Part III of the Schedule may be compounded for a sum not exceeding \$100.
