In exercise of the powers conferred by section 3(*d*) of the Prisons Act, the Minister for Home Affairs makes the following Notification:

**Citation and commencement**

1. This Notification is the Prisons (Declaration of Reformative Training Centres) Notification 2018 and comes into operation on 1 July 2018.

**Declaration of reformative training centres**

2. The Minister declares the places set out in the Schedule to be reformative training centres for the purposes of the Act for the detention of persons sentenced to reformative training.

**Cancellation**

3. The following Notifications are cancelled:

- (a) the Notification relating to Declaration of Changi Women's Prison as Reformative Training Centre (G.N. No. S 256/2002);

- (b) the Prisons (Declaration of Reformatory Training Centres) Notification 2004 (G.N. No. S 9/2004);
- (c) the Prisons (Declaration of Reformatory Training Centres) Notification 2009 (G.N. No. S 263/2009);
- (d) the Prisons (Declaration of Reformatory Training Centre) Notification 2011 (G.N. No. S 333/2011).
