In exercise of the powers conferred by section 4(1) of the Protected Areas and Protected Places Act, the Minister for Home Affairs makes the following Order:

**Citation and commencement**

1. This Order is the Protected Areas (No. 3) Order 2016 and comes into operation on 1 January 2017.

**Area declared to be protected area**

2.—(1) The area described in the second column of the Schedule is declared to be a protected area for the purposes of the Act.

(2) Every person who is in that area must comply with such directions for regulating the person's movement and conduct as may be given by an authorised officer acting by or on behalf of the authority specified in the first column of the Schedule.


