**ARRANGEMENT OF REGULATIONS**

**Regulation**

1. Citation and commencement

In exercise of the powers conferred by section 109(2) of the Parliamentary Elections Act, the Prime Minister hereby makes the following Regulations:

**Citation and commencement**

1. These Regulations may be cited as the Parliamentary Elections (Composition of Offences) Regulations 2006 and shall come into operation on 19th April 2006.

**Compoundable offences**

2. The following offences may be compounded by the Returning Officer, or any officer of the Elections Department who is authorised by the Returning Officer, in accordance with section 109(1) of the Act:

- (a) any corrupt practice under section 61(1)(c)(i) of the Act as in force immediately before 14 June 2024;

- (b) any corrupt practice under section 61(1)(c)(ii) of the Act as in force immediately before 14 June 2024 read with regulation 3 of the Parliamentary Elections (Election Advertising) Regulations (Rg 3) revoked on 14 June 2024;

- (ba) any corrupt practice under section 61B(1) or (2) of the Act;
