In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

**Citation**

1. This Order may be cited as the Remote Gambling (Exemption) (No. 3) Order 2015.

**Definitions**

2. In this Order, unless the context otherwise requires —
  - “draw” means the draw to be held on 21 July 2015 pursuant to the game;
  - “Emirates Singapore Derby website” means the website at <http://www.derby.sg>;
  - “game” means the “Match & Win” game, for participation by members of the STC Facebook Fan Page, which is to be made available from 26 June 2015 to 13 July 2015 (both dates inclusive);

“STC” means the Singapore Turf Club;

“STC Facebook Fan Page” means the website at <http://www.facebook.com/SGTurfClub>.

### **Exemption**

3.—(1) The STC is exempt from sections 11, 15 and 17 of the Act in respect of the game and the draw.

(2) The exemption is subject to compliance by the STC with the conditions specified in the Schedule.

## THE SCHEDULE

Paragraph 3(2)

### CONDITIONS

1. The STC may —
  - (a) promote, or authorise the promotion of, the game or the draw; or
  - (b) publish, or authorise the publication of, any advertisement relating to the game or the draw,  
only on all or any of the following online locations:
    - (i) the STC Facebook Fan Page;
    - (ii) the Emirates Singapore Derby website;
    - (iii) the STC corporate website at <http://www.turfclub.com.sg>.
2. All the following details must be included in publicity material that must be freely accessible to every participant of the draw:
  - (a) the details of the prizes to be distributed;
  - (b) the manner in which the prizes will be distributed;
  - (c) the time, date and place of the draw;
  - (d) how a person may participate in the draw;
  - (e) the manner in which the draw is conducted.
3. The STC must keep a record of the name and electronic mailing address of every participant of the draw.
4. The draw must be conducted in public by officers of the STC.

THE SCHEDULE — *continued*

5. The STC must undertake to ensure that —
- (a) every winner is notified by telephone or in writing by electronic means; and
  - (b) the results of the draw are published on the STC Facebook Fan Page and the Emirates Singapore Derby website.
6. The STC must, before the start of the draw, undertake to ensure that an audited statement of the accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, Singapore Police Force, no later than 22 October 2015.
