REMOTE GAMBLING (SENTOSA DEVELOPMENT CORPORATION — EXEMPTION) ORDER 2021

In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

Citation

1. This Order is the Remote Gambling (Sentosa Development Corporation — Exemption) Order 2021.

Definitions

- **2.** In this Order, unless the context otherwise requires
 - "lottery" means the scratch card game in which a person may participate by making an online redemption of SingapoRediscovers vouchers as part of the promotion and redeeming a scratch card at Sentosa Ticketing Counters from 28 June 2021 to 30 September 2021 (both dates inclusive);
 - "organiser" means the Sentosa Development Corporation established by section 3 of the Sentosa Development Corporation Act (Cap. 291);

- "promotion" means the promotion called "Sentosa SingapoRediscovers Scratch & Win Campaign" that is to be made available from 28 June 2021 to 30 September 2021 (both dates inclusive) on websites and social media platforms maintained by the following persons:
 - (a) Changi Travel Services (UEN 201207884G);
 - (b) GAADIT Pte Ltd (Globaltix) (UEN 201602979R);
 - (c) Klook Travel Technology Pte Ltd (UEN 201604352Z);
 - (d) Traveloka Services Pte Ltd (UEN 201509260N);
 - (e) Trip.com Travel Singapore Pte Ltd (UEN 201613701E).

Exemption

- **3.**—(1) The organiser is exempt from sections 11, 13, 15 and 17 of the Act in respect of the promotion and the lottery.
- (2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 3(2)

CONDITIONS

- 1. All the following details must be included in publicity material that must be freely accessible to every participant of the lottery:
 - (a) the name and address of the organiser;
 - (b) the details of the prizes to be distributed;
 - (c) the manner in which the prizes will be distributed;
 - (d) the time, date and place of the lottery;
 - (e) how a person may participate in the lottery;
 - (f) the manner in which the lottery is to be conducted.
- 2. The organiser must keep a record of the name and contact number of every participant of the lottery.

THE SCHEDULE — continued

3. The organiser must, before the start of the lottery, undertake to ensure that an audited statement of accounts and the results of the lottery are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, Singapore Police Force, no later than 31 December 2021.
