REMOTE GAMBLING (EXEMPTION) (NO. 2) ORDER 2018

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

Citation

1. This Order is the Remote Gambling (Exemption) (No. 2) Order 2018.

Definitions

- 2. In this Order, unless the context otherwise requires
 - "draw" means any draw to be held as part of the promotion at 1 Hampshire Road, Singapore 219428 between 2 p.m. and 4 p.m. on the following dates:
 - (a) 10 August 2018;
 - (b) 14 September 2018;
 - (c) 12 October 2018;
 - (*d*) 9 November 2018;

- (e) 14 December 2018;
- (*f*) 11 January 2019;
- "organiser" means the Land Transport Authority of Singapore established by section 3 of the Land Transport Authority of Singapore Act (Cap. 158A);
- "promotion" means the promotion called "ATU Lucky Draw for Senior Citizens" from 1 July 2018 to 11 January 2019 (both dates inclusive) —
 - (a) in brochures distributed at community centres;
 - (b) on the website at https://www.transitlink.com.sg; and
 - (c) on the Facebook and Twitter social media platforms maintained by either or both the organiser and Transit Link Pte Ltd;

"public accountant" has the meaning given by section 2(1) of the Accountants Act (Cap. 2).

Exemption

3.—(1) The organiser is exempt from sections 11, 12, 15 and 17 of the Act in respect of the promotion and the draws.

(2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 3(2)

CONDITIONS

- 1. All the following details must be included in publicity material that must be freely accessible to every participant of a draw:
 - (a) the name and address of the organiser;
 - (b) the details of the prizes to be distributed;
 - (c) the manner in which the prizes will be distributed;
 - (d) the time, date and place of the draw;
 - (e) how a Senior Citizen Concession Card holder may participate in the draw;

THE SCHEDULE — continued

- (f) the manner in which the draw is to be conducted.
- 2. The organiser must keep a record of the name and address of every participant of a draw.
- 3. Only persons in the employment of the organiser may conduct a draw.
- 4. Each draw must ----
 - (a) be conducted in public; or
 - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of the organiser.
- 5. The organiser must undertake to ensure that
 - (a) every winner is notified in writing by post; and
 - (b) the results of each draw are published
 - (i) on the website at https://www.transitlink.com.sg; and
 - (ii) on the Facebook and Twitter social media platforms maintained by either or both the organiser and Transit Link Pte Ltd.
- 6. The organiser must, before the start of any draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 12 April 2019.
