REMOTE GAMBLING ACT 2014 (ACT 34 OF 2014)

REMOTE GAMBLING (EXEMPTION) (NO. 6) ORDER 2018

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

Citation

1. This Order is the Remote Gambling (Exemption) (No. 6) Order 2018.

Definitions

2. In this Order, unless the context otherwise requires —

“draw” means the draw to be held at 12 noon on 15 May 2019 at 3 Second Hospital Avenue, Singapore 168937, as part of the promotion;

“organiser” means the Health Promotion Board established by section 3 of the Health Promotion Board Act (Cap. 122B);

“promotion” means the promotion called “National Step ChallengeTM Season 4” that is to be made available from 27 October 2018 to 30 April 2019 (both dates inclusive) on the Healthy 365 mobile application platform maintained by the organiser;

“public accountant” has the meaning given by section 2(1) of the Accountants Act (Cap. 2).

Exemption

3.—(1) The organiser is exempt from sections 11, 13, 15 and 17 of the Act in respect of the promotion and the draw.

(2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 3(2)

CONDITIONS

1. All the following details must be included in the publicity material that must be freely accessible to every participant of the draw:
 - (a) the name and address of the organiser;
 - (b) the details of the prizes to be distributed;
 - (c) the manner in which the prizes will be distributed;
 - (d) the time, date and place of the draw;
 - (e) how a person may participate in the draw;
 - (f) the manner in which the draw is to be conducted.
2. The organiser must keep a record of the name, telephone number and email address of every participant of the draw.
3. Only persons in the employment of the organiser may conduct the draw.
4. The draw must —
 - (a) be conducted in public; or
 - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of the organiser.

THE SCHEDULE — *continued*

5. The organiser must undertake to ensure that —
- (a) every winner is notified by telephone; and
 - (b) the results of the draw are published —
 - (i) on the website at <https://www.healthhub.sg/programmes/37/nsc>; and
 - (ii) in an English local daily newspaper.
6. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, Singapore Police Force, no later than 16 August 2019.
