In exercise of the powers conferred by section 34(2) of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

PART I
PRELIMINARY

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Service) Rules 2006 and shall come into operation on 27th February 2006.

Definitions

2. In these Rules, “account with the electronic service”, “authentication code”, “electronic record”, “electronic service” and “electronic service agent” have the meanings given to those expressions in section 33B(13) of the Act.

PART II
ELECTRONIC SERVICE AGENTS

Factors to consider for registration

3. The Authority shall have regard to the following matters in determining whether to register a person as an electronic service agent:

- (a) his character and fitness to be an electronic service agent;

- (b) whether he is carrying on any business which involves filing or submitting on behalf of others any document referred to in rule 8;
 - (c) his financial standing;
 - (d) any prior relevant experience which he has in filing with or submitting to the Registrar on behalf of others any document referred to in rule 8;
 - (e) his ability to provide a reliable and efficient service as an electronic service agent;
 - (f) any other matters which the Registrar considers relevant.

Cancellation or suspension of registration

4.—(1) The Authority may cancel, or suspend for such period as it may determine, the registration of an electronic service agent if —

- (a) he fails to use the electronic service for a continuous period of 90 days (including Sundays and public holidays);
- (b) the Authority is satisfied that he had contravened any provision of Part I of the Act or any rules made thereunder (including any provision of these Rules), or any condition of his registration;
- (c) the Authority is satisfied that he had knowingly furnished false or misleading information in his application for registration, or in any document filed with or submitted to the Authority through the electronic service; or
- (d) he is no longer carrying on a business referred to in rule 3(b).

(2) The Authority shall notify an electronic service agent of any suspension or cancellation referred to in paragraph (1) together with the reason for it.

Application for suspension or cancellation of registration

5.—(1) An electronic service agent may apply to the Authority, in such manner as the Authority may specify, for the suspension or cancellation of his registration.

(2) The Authority may grant the application subject to such conditions as it deems necessary.

Change of particulars

6. An electronic service agent shall, in the manner specified by the Authority —

- (a) inform the Authority of any change in any particulars furnished in his application for registration as an electronic service agent; and
- (b) inform the Registrar of any revocation of his authority to act as an agent for another person for any matter.

Inspection of records and accounts

7.—(1) The Authority or a person authorised in writing by the Authority may at any time require an electronic service agent to make available for the Authority or person's inspection any record or account which the electronic service agent is required to keep as a condition of his registration.

(2) The electronic service agent shall render such reasonable assistance as the Authority or person may require for the inspection.

PART III

Documents which may be filed or served through electronic service

8.—(1) The documents set out in First Schedule may be filed with or submitted to the Registrar through the electronic service.

(2) The documents set out in the Second Schedule may be served by the Registrar through the electronic service on any person.

Hard copy of document to be given to Registrar

9.—(1) Unless otherwise specified in such circular as may be issued by the Authority under rule 14, a hard copy of any document

that has been filed with or submitted to the Registrar through the electronic service has to be filed with the Registrar not later than 7 days after such filing or submission or such longer period as the Registrar may allow in any particular case.

(c) an application under rule 5(1) or (2), 6(1) or 9(1) of the Road Traffic (Registration of Power-Assisted Bicycles) Rules 2017;

(d) a notice of error or omission, notice of change in particulars or request to withdraw an application under rule 7(1) of the Road Traffic (Registration of Power-Assisted Bicycles) Rules 2017;

- (g) a document submitted to the Registrar to satisfy the Registrar that the registration of a vehicle should be cancelled under section 27(1)(d)(i), (ii) or (iv) or (f) of the Act.

Authorisation of electronic service agent and revocation of his authority

10.—(1) For the purposes of section 33B(4) of the Act —

- (a) the authorisation by a person of an electronic service agent to be his agent for any matter other than an application referred to in sub-paragraph (b) shall be made by him in the appropriate part of the copy of the form required to be filed with the Registrar under rule 9(1); and
- (b) the authorisation by a person of an electronic service agent to be his agent for an application under rule 35(2) of the Road Traffic (Motor Vehicles, Registration and Licensing) Rules may be done in any manner permitted by law.

(2) For the purposes of section 33B(5) of the Act and unless the Registrar otherwise permits in any particular case, the revocation by a person of his authorisation of an electronic service agent to be his agent for any matter shall be made in writing under his hand and delivered by him personally to the office of the Registrar.

Manner of payment of fee, etc.

11. Any fee, tax, levy, deposit or other charge payable in respect of any document filed with or submitted to the Registrar through the electronic service shall be paid by means of cash, cheque, cashier's order or its equivalent, money or postal order, virtual account, inter-bank GIRO, direct debit from or credit to a bank account, telegraphic transfer, Inter-Business Unit Journal Voucher, or such credit card, debit card, automated teller machine (ATM) card or stored value card as the Registrar may approve.

Cancellation or suspension of account or authentication code

12.—(1) The Authority may cancel, or suspend for such period as it may determine, any account with the electronic service or any authentication code, if —

- (a) the Authority is satisfied that the holder of the account or authentication code had contravened any provision of Part I of the Act or any rules made thereunder (including any provision of these Rules), or any condition subject to which the account or authentication code was assigned to him;
- (b) the Authority is satisfied that he had knowingly furnished false or misleading information in his application for the account or authentication code, or in any document filed with or submitted to the Authority through the electronic service;
- (c) in a case where the authentication code was assigned to a person for a particular matter and he had authorised an electronic service agent to act for him for that matter, the Authority is satisfied that such authorisation had been revoked;
- (d) in a case where the account or authentication code was assigned to an electronic service agent —
 - (i) the electronic service agent is no longer carrying on a business referred to in rule 3(b); or
 - (ii) the electronic service agent had been wound up or otherwise dissolved, or a receiver, receiver and manager or judicial manager had been appointed in respect of his property, or (if he is an individual) he is an undischarged bankrupt; or
- (e) the Authority is satisfied that the account or authentication code is no longer needed.

(2) The Authority shall notify the holder of the account or authentication code of any suspension or cancellation referred to in paragraph (1) together with the reason for it.

Application for suspension or cancellation of account or authentication code

13.—(1) The holder of an account with the electronic service or authentication code may apply to the Authority, in such manner as the Authority may specify, for the suspension or cancellation of the account or authentication code, and (if applicable) the re-assignment of a new authentication code.

(2) The Authority may grant the application subject to such conditions as it deems necessary.

PART IV**MISCELLANEOUS****Circulars**

14. The Authority may issue circulars whether in a physical or electronic form which provides for —

- (a) the manner of application for registration as an electronic service agent, or for an account with the electronic service or an authentication code;
- (b) the manner of assignment of such account or code;
- (c) the manner in which documents are to be filed, submitted or retrieved through the electronic service; and
- (d) any other matter relating to the use of the electronic service.

Service bureaux

15.—(1) The Authority may permit any person to establish or operate one or more service bureaux to assist in the filing or submission of documents through the electronic service.

(2) Any person who establishes or operates a service bureau shall not be considered an agent of the Authority.
