### ROAD TRAFFIC (TEMPORARY PRIVATE HIRE CARS) (EXEMPTION) (NO. 3) ORDER 2011

#### ARRANGEMENT OF PARAGRAPHS

##### Paragraph

In exercise of the powers conferred by section 142 of the Road Traffic Act, the Minister for Transport hereby makes the following Order:

#### **Citation**

1. This Order may be cited as the Road Traffic (Temporary Private Hire Cars) (Exemption) (No. 3) Order 2011.

#### **Exemption**

2. Section 101 of the Act shall not apply to a vehicle which bears any registration number set out in the Schedule and which —

- (a) is used as a private hire car between 3rd June 2011 and 13th June 2011 (both dates inclusive) by Experia Events Pte Ltd for the purpose of the event known as the ScreenSingapore 2011;
- (b) has valid insurance cover for its use as a private hire car when it is so used; and

- (c) displays a label issued by the Registrar in such manner as he may require.
