ROAD TRAFFIC (TRIFACTOR TRIATHLON SINGAPORE 2022 — EXEMPTION) ORDER 2022

In exercise of the powers conferred by section 142 of the Road Traffic Act 1961, the Minister for Transport makes the following Order:

Citation

1. This Order is the Road Traffic (TriFactor Triathlon Singapore 2022 — Exemption) Order 2022.

Definitions

2. In this Order —

“Orange Room Pte. Ltd.” means the company incorporated under the Companies Act 1967 as Orange Room Pte. Ltd. (UEN 200811733N);

“specified event” means the TriFactor Triathlon Singapore 2022 organised by Orange Room Pte. Ltd. on 4 September 2022;

“specified motor cycle” means any of the motor cycles bearing the following vehicle registration numbers:

(a) FBB5914X;

(b) FBM6090H;

(c) FBP209H;

“specified road” means the road delineated by the black-coloured line in the map set out in the Schedule.

Exemption for riding bicycle

3. Section 120(3) of the Act does not apply to an individual who rides a bicycle on the specified road during the specified event under the following conditions:

- (a) the individual is a registered participant of the specified event;
- (b) there is in force, at any time the bicycle is ridden in connection with the specified event, a policy of insurance in relation to the bicycle insuring against any liability in respect of —
 - (i) the death of or bodily injury sustained by any person (other than the rider of the bicycle); and
 - (ii) any property damage suffered by any person (other than the rider of the bicycle),
caused by or arising out of the use of the bicycle;
- (c) the risk under the policy of insurance mentioned in sub-paragraph (b) is assumed by an insurer who, at the time of the issuance of the policy, is lawfully carrying on an insurance business in Singapore.

Exemption for driving specified motor cycle

4. Section 120(3) of the Act does not apply to an individual who drives a specified motor cycle on the specified road during the specified event under the following conditions:

- (a) the individual is authorised by Orange Room Pte. Ltd. to drive the specified motor cycle in connection with the specified event;
- (b) the individual who drives the specified motor cycle possesses a valid driving licence granted under the Road
